The Majlis (AC) conducted the following business:

AC-2008(III): Res.-1

<u>Discussion on the Academic Matters of the University.</u>

Initiating the meeting, the Vice-Chancellor (Chairman), first of all, expressed his thanks to all the Deans of Faculties, Dean, Students' Welfare, all HoDs, Directors of the Centres, Controller of Examinations and other Administrative/supporting staff for their much needed co-operation in completing the examinations of the University quite smoothly. He also sought all the concerned members to extend their support at all levels in conducting the admission affairs for the Academic Session-2008-09 in a smooth manner.

Further, the Chairman apprised the Majlis (AC) of his having attended the meeting of Vice-Chancellors of the Central Universities with Shri Arjun Singh Ji, Hon'ble Minister of HRD and the officers of the Ministry held in the MHRD on May 14, 2008. While speaking about the decision taken in the meeting, he informed that Jamia Millia Islamia has been allowed to continue with its existing reservation policy in admission, which provides 25% reservation of Jamia's internal candidates and Jamia shall not come within the purview of the recently notified reservation policy for OBCs.

The decision of the MHRD for providing exemption to Jamia as stated in the preceding para, was based on the consideration of the fact that the Jamia Millia Islamia has a unique historical character of great national importance, and which calls for maintaining the internal continuity by continuing its age-old 25% reservation in admission for internal candidates.

Further, the Vice-Chancellor (Chairman) informed that all the teachers, who have been appointed in the Centres of the University, have to remain present in the Centres during duty hours. He has decided to constitute two Committees of eminent scholars to review the functioning of the Centres, including the academic programmes and researches being conducted by them. The said Committees will also suggest the corrective measures to improve the functioning of the Centres.

Thereafter, The Majlis (AC) thanked the Vice-Chancellor with an applause for the efforts made by him and his team, specially Prof. Zubair Meenai, Dean, Students' Welfare, for retaining 25% Internal reservation for admissions in the Jamia Millia Islamia, and resolved that a letter of appreciation should also be sent to the MHRD for their favourable consideration of the matter and allowing the University to continue with its reservation policy, thereby maintaining its historical character. The Majlis (AC) also resolved to endorse all the actions being taken by the Vice-Chancellor for improving the functioning of the Centres in Jamia.

The meeting was concluded at 5:00 p.m. with a vote of thanks to the Chair.
