Diploma in Acting, Advance Diploma in Catalan, Certificate course in Chinese language and Communicative English programs etc., excelled in all spheres particularly in entrepreneurship and in the field of sports as well by lifting prestigious titles and also represented University

in Shooting at the World University Games in Russia. He also informed about the future initiative such as introduction of payment of online fee, promote e-Learning to share study materials, submission of assignments and to build data base of our students. He further informed that the University has applied for accreditation by NAAC, which is a mandatory requirement of all the Universalities. The *Anjuman* (Court) was also informed that there has been reasonable increase in the strength of girl students after getting Minority Institution status. Prof. Akhtarul Wasey, Director, Zakir Husain Institute of Islamic Studies, got Padmashree and Dr. Abdur Rub, Department of Biotechnology, JMI, won the Indian National Science Academy Medal for Young Scientist.
