AC-2011 (V): Item-01

To report the Hon'ble Delhi High Court order delivered on three petitions challenging the Order of the National Commission for Minority Educational Institutions, which was heard on 18.5.2011

The Vice-Chancellor apprised the Majlis (AC) about the Hon'ble Delhi High Court order delivered on three petitions challenging the Order of the National Commission for Minority Educational Institutions, which was heard on 18.5.2011.

The Majlis (AC) noted the contents of the Delhi High Court order dated 18.5.2011 and unanimously agreed to proceed with the revised Reservation Policy of the University as approved by the Academic Council 29.3.2011 and Executive Council dated 01.04.2011 concerning "Reservation of Seats and Other Special Provision for Admission".

While approving the above Resolution, the Majlis (AC) authorized the Vice-Chancellor for appropriate amendment to be made in Ordinance VIII(8), IX (9) (Academic) and any other Ordinance consequent upon the amendment and implementation of the revised reservation policy of the University.

Before concluding the meeting, the Vice-Chancellor, apprised the Majlis (AC) about his visit to Saudi Arabia. While appreciating the efforts made by Prof. Zikrur Rahman, Director, India Arab Cultural Centre, in ensuring its success, members were informed about his meetings notably with the brother of King Abdullah-bin-Abdul Aziz, Prince Salman-bin-Abdul Aziz, the Governor of Riyadh who gave 40 minutes long audience to the delegation of Jamia Millia Islamia and fondly recalled his Jamia's visit in the past.

Besides, Jamia Millia Islamia delegation has given importance by the Kingdom authorities. The Secretary General of King Abdul Aziz foundation for Research and Archives, the official host, spent one full day with the Jamia delegation working various aspects of collaboration. The Foundation decided to make Jamia Millia Islamia the Nodal Agency to create an archival library on Haj affairs in South Asia. An agreement to this effect has been finalized and is awaiting the Saudi Cabinet approval.

He also informed about the two separate Memorandum of Understandings (MoUs) signed by Jamia, one with Imam Mohammad bin Saud University the other with King Saud University on exchange of scholars and faculty in the field of Sciences and Humanities. Five Postgraduate/Doctoral Scholarships were approved for the Jamia students by the King Saud University along with the establishment of a Chair in the name of King Abdullah-bin-Abdul Aziz. He also informed that a request for another Chair in the name of Prince Salman-bin-Abdul Aziz was made and it was promised to be considered favorably by the Rector of King Saud University.

The meeting concluded at 11.30 a.m. with a vote of thanks to the Chair.
