### **Confirmation of Services**

Hence, he had requested for revocation of suspension orders. The Executive Council noted that his suspension order was in accordance with Statute 37(1) of JMI Act, 1988. On perusal of entire records, the Executive Council endorsed the decision of the Vice-Chancellor to suspend Prof. M.G. Husain. Further, the Vice-Chancellor was directed to initiate appropriate disciplinary proceedings against him.

### EC-2011(VIII):Reso.-06

Decision on the proposal of Central Bureau of Investigation, Chennai regarding initiation of Regular Departmental Action (RDA) for major penalty against Prof. M. Altaf Khan, Department of Commerce and Business Studies (in his capacity as a member of the Moderation Committee of AICTE).

The entire case of Prof. M. Altaf Khan, Department of Commerce & Business Studies with regard to the CBI's directives for initiation of Regular Departmental Action (RDA) along with CBI's letter and his reply was placed before the Majlis (EC). The matter was deliberated at length. It was noted that Prof. M. Altaf Khan was not the main accused in the case, and no criminal case has been registered against him by the CBI. He was only a member of Moderation Committee. The Majlis (EC) therefore found it difficult to order Regular Departmental Action at this stage. It was therefore, resolved to come back to Majlis (EC) along with legal advice as to whether any disciplinary action can be initiated against Prof. M. Altaf Khan in the facts and circumstances of the case.

### Approval of the proposal for improvement in the functioning of Legal Cell.

The Majlis (EC) approved the following proposal in order to improve the functioning of the Legal Cell of the University:

- 1. In order to give a boost to the functioning of the Legal matters and the lego-administrative issues, Legal Advisor will be designated as Chief Legal Advisor on a consolidated remuneration of Rs. 40,000/p.m. and another lawyer who is familiar with Jamia's legal matters may be appointed as Assistant Legal Advisor. Ms. Jaya Goel, Advocate who has since very long been associated with the university will be appointed for this position with a remuneration of Rs.15,000/- per month. She may visit the university three days a week.
- 2. The Legal matters of the university shall continue to be marked at the advice of the "Chief Legal Advisor cum Standing Counsel of Jamia". He can take up such matters himself or mark them to other panel lawyers according to complexities involved, and even appear for final/ regular arguments (if the situation so warrants).
- The Assistant Legal Advisor shall be required to vet the documents and opine on queries, draft documents, MOUs, Agreements, Notices, Memorandum, RTI related correspondence etc. On complex issues, the said Assistant Legal Advisor shall confer with the Chief Legal Advisor.
- 4. Assistant Legal Advisor shall also be required to take up matters before various authorities and quasi judicial commissions but may engage the services of the Chief Counsel as and when required.
- 5. The Chief Legal Advisor shall continue to appear before various Inquiring Authorities, as Presenting Officer of the University, where special inquiries are directed to be held either by the Visitor, the Ministry, the Executive Council and/ or the Vice-Chancellor.
- 6. As a matter of policy, and keeping in view the keen sense of responsibility in Sh. Atyab Siddiqui, it was decided in 1999 that all Affidavits on behalf of the Registrar (in the High Court and the Supreme Court) shall be drafted by him. This was following the embarrassing situation that a number of conflictory affidavits were filed by different Counsels in various matters inviting judicial

strictures and creating a legal faux pas for the Registrar. This policy needs to be continued as such to maintain uniformity and prevent awkward situations for the university.

Decision on the legal expenses on the matter pertaining to the declaration of Jamia Millia Islamia as Minority Educational Institution by the National Commission for Minority Educational Institutions.

The Majls (EC) was informed about the several petitions filed in the Hon'ble High Court of Delhi against the declaration of Jamia Millia Islamia as a Minority Educational Institution by the National Commission for Minority Educational Institutions (NCMEI). The University has till date incurred legal expenses of more than Rs.21.00 lakhs. Since, it is high



profile litigation, it is reasonably expected that the University shall have to incur huge expenses in the form of professional fees to leading lawyers and incidental disbursement.

The Majlis (EC) was also informed that the MHRD has filed an Affidavit in the Hon'ble High Court of Delhi stating that the Government respects the order of the National Commission for Minority Educational Institutions (NCMEI).

The Majlis (EC) noted that these legal expenses are inevitable and suggested that the Finance Committee should make suitable budgetary provision for the same.
