### Action taken by the Vice-Chancellor regarding two posts of Assistant Professors in the Faculty of Dentistry.

The *Majlis* (EC) noted that the UGC has sanctioned 13 posts of Lecturers (now re-designated as Assistant Professors) in the Faculty of Dentistry. It also noted that the Executive Council in its meeting held on 25/11/2008 had approved two posts of Tutors out of these 13 posts of lecturers sanctioned by the UGC for a period of three years. The following Tutors were appointed for tenure of three years against these two posts:

1. Dr. Yusra Khan, w.e.f. 02/02/2009 2. Dr. Sanobia Ahmad w.e.f. 06/02/2009

The above two Tutors shall be completing their tenure of three years on 01/02/2012 and 05/02/2012 respectively. It was earlier proposed by the Dean, Faculty of Dentistry to restore these two posts as Assistant Professors. Hence, the Vice-Chancellor in anticipation of the approval of the *Majlis*-i-Muntazimah (Executive Council) approved to advertise these posts in the disciplines of Oral Diagnosis and Pediatrics, and preventive Dentistry.

The *Majlis* (EC) was informed this issue was discussed in the Faculty Committee held on 19.01.2012, in which the Dean informed the Faculty Committee that although UGC sanctions posts of Asstt. Professors only, and not of Tutors, the Professors of the Faculty feel that at least one post as Tutor should be retained to aid academic. BDS Tutor can be easily relocated to various Departments in any emergent situation. It was agreed by the Faculty Committee that at least one post of Asstt. Professor (Pediatric & Preventive Dentistry) may be converted as Tutor on permanent basis.

The *Majlis* (EC) noted the above development and agreed to retain one post of Tutor on permanent basis and one post of Asstt. Professor (Oral Diagnosis & Radiology) already advertised may be filled.
