# Conference Background and Objectives

That Human Development Indices are closely related to Early Childhood Development is well understood. It is also agreed that it is in a country's best interest to enable all children to benefit from the equalizing and enabling power of Early Childhood Development (ECD). Through a combination of national social policies and international articulations including the Millennium Development Goals (MDGs), the Education for All (EFA) goals and the World Fit for Children (WFFC) targets, countries are working to ensure optimal developmental conditions for the world's children, including universal access to quality basic education. However, worldwide evidence highlights the persistence of inequity in enrolment, attendance, learning outcomes and achievement based on gender, poverty, geographical location, ethnicity, health status, conflict and natural disasters. In such a situation, the national ECD policy frameworks can be important tools for creating enabling environments and advocating for adequate funding of ECD related interventions.

Policies often include provisions for building effective co-ordination systems for maximizing the use of resources. They usually call for integrated approaches to ECD training, curricula and methods. The policy planning process also promotes the expansion of national and international investment in ECD, including private sector resources. Finally, most policies establish ECD indicators, databases, evaluation and monitoring systems and action research programmes. The holistic nature of child development requires the involvement of multiple partners across governments, parents, communities, non-governmental organizations, and other stakeholders. This integrated and participatory approach to ECD policy planning is of key importance to achieving successful policy development and implementation.

Recently, India has formulated the National ECCE policy in 2013. The policy conforms to the vision of holistic and integrated development of the child, with focus on care and early learning at each sub stage of development continuum. The vision is to achieve holistic development and active learning capacity of all children below 6 years of age by promoting free, equitable universal, inclusive joyful and contextual opportunities for laying down foundation and attainment of full potential. It provides for quality ECCE provisions addressing issues of parental participation, inclusion, equity, institutional capacity building monitoring.

However, many policy instruments impinging on young children have been mere declaration of intent than realities. The preparation of a policy is not an end in itself. Rather, the adoption of a National ECD Policy or Policy Framework is only the first step in a long-term process for expanding and improving services for young children and their families.

Some of the challenges in the policy led framework need to be articulated in detail for better understanding. It is seen that often poor policy frame works presents a fragmented approach and are not holistic in nature. Policies sometime remain more of a statement of intent rather than realities as Policies and international laws are seldom backed by enforcements at the national and local level.

The multi-sectoral nature of ECD necessitates policy decisions spanning multiple ministries (e.g. health, education, nutrition, rural development,

women and child development) where no one administrative body has the principle responsibility, government may neglect ECCE, and fragmented responsibility may lead to disparities in access and quality. It has also been seen that often ECD Policies are not integrated with national development plans and poverty reduction strategies. Often, disadvantaged children remain neglected in most cases and the access remains inequitable due to lack of financing and policy frameworks since allocation to ECD in national budget remain small and inadequate in many developing and poor countries.

The above mentioned challenges related to access, equity and quality faced by developing countries need to be analyzed in post 2015 scenario with reference to the recent shift from MDGs to SDGs (Sustainable Development Goals). Thus, the Third International Conference on ECD at Jamia Millia Islamia, New Delhi will aim at analyzing how ECD policies have taken shape in the developing countries over past decades. The conference also intends to analyze the context in which the ECD policies and programmes are implemented and the progress achieved through them. The conference will also help in understanding the regional ECD environment in terms of financing ECD, monitoring, evaluation and evaluation and implementation strategies among other aspects.
