CONFERENCE BACKGROUND AND OBJECTIVES:

Health and development are interrelated; it is important to study the direct linkages and various socio-economic determinants of health. It is evident from the empirical studies that systematic healthcare initiatives raised labour productivity; improve life expectancy and standard of living. The key goals of public health systems across democratic countries are to reduce population exposure to diseases, vector control, health education, assure food safety and provision of primary healthcare services.

The global conference aims to bring various stakeholders including generalists and specialists to debate and discuss policy issues relating to the public health infrastructure, evidence-based public health practice, emerging issues, and innovative approaches in reinventing health care service delivery and development. The conference will include research papers, case studies, policy briefs, systematic reviews, secondary case reviews, field observations, reviews of government programmes, project reports, and doctoral and post-doctoral research findings. In brief, each of the technical sessions broadly examines the changing needs for a sustainable public health infrastructure, impact of reforms in the healthcare sector and stakeholders' participation in health service delivery.

ABOUT THE ORGANISERS:

A. Jamia Millia Islamia and the Department of Social Work, New Delhi, India

The University of Minnesota was founded as a preparatory school in 1851, seven years before the territory of Minnesota became a state. Financial problems forced the school to close during the Civil War, but with the help of Minneapolis entrepreneur John Sargent Pillsbury, it reopened in 1867. Known as the father of the University, Pillsbury, who was a University regent, state senator, and governor, used his influence to establish the school as the official recipient of public support from the Morrill Land-Grant Act, designating it as Minnesota's land-grant university. William Watts Folwell was inaugurated as the first president of the University on December 22, 1869. In 1873, two students received the first Bachelor of Arts degrees. In 1888, the first Doctor of Philosophy degree was awarded. The





Duluth campus joined the University in 1947; the Morris campus opened in 1960, and the Crookston campus in 1966, and the Rochester campus in 2006.

The mission of the School of Public Health is to preserve and enhance the health of the public through education, research, and service programs designed to discover and transmit new knowledge aimed at the prevention of disease and disability, the improvement of health, and the planning, analysis, management, evaluation, and improvement of systems for the delivery of health services. Our school was founded in 1944, although public health courses have been offered at the University of Minnesota since its inception. We consistently rank among the top schools of public health in the country. Through our education, research, and community outreach, we focus on improving the health of populations. We emphasize prevention of illness and injury, and we look at health through a multi-faceted prism that includes physiology, the environment, communities, economics, and public policy.

ABSTRACT AND PAPER SUBMISSION FORMAT REQUIREMENTS AND SUBMISSION INSTRUCTIONS:

- 1. Papers on the listed themes must be sent by email to iph2015@gmail.com
- 2. Papers must be in Microsoft Word.
- 3. Papers must be written in English.
- 4. Your submission should include a separate page containing:
 - Title of paper
 - Suggested topic and sub theme
 - Name(s) of authors
 - Organization/institution affiliation
 - Contact address, telephone, fax and e-mail address
- 5. Author's names should be on the title page only, in order to facilitate the blind referring process.
- 6. Papers and abstracts will only be accepted for review on the condition that the manuscript has not been copyrighted, has not been published, has not been presented or accepted for presentation at professional meetings, and is not currently under review for presentation at other professional meetings. A declaration to this effect must accompany the final paper in the format given.
- 7. Authors must intend to register for, and attend, the conference to present the paper if it is accepted.
- 8. All accepted papers will be published in the edited book, provided completed papers are received by the appropriate deadline and conform to the format and length requirements.

MANUSCRIPT PREPARATION:

- The manuscript must be typed, 1.5 spaced (single-spaced for indented material, notes and references). All heading including title should be 12 in Times New Roman and text should be 12 point Times New Roman. Margins must be of 1 inch on all sides.
- Papers should not exceed 5000 words.
- Abstract should be of maximum 300 words and authors biography 150 words





- Follow the mentioned order when typing manuscript: Title, Authors, Affiliation, Abstract, Keywords, Main text, Acknowledgements, Appendix and References.
- All photographs, charts and diagrams are to be referred to as "Figures" and should be numbered consecutively in the order to which they are referred in the text.
- List of references must be arranged in alphabetical order.
- For text citations, papers should be referred to as (Sharma 2010) and papers by the same author in the same year should be distinguished by lettering in sequence (2010a, 2010b, etc). Where papers are not by more than three authors, all names should be cited, otherwise the first name should be followed by 'et al'.
- Referencing should be given in the following format:
 - i. **Books:** Baru, R. 1998. *Private Health Care in India: Social Characteristics and Trends*. New Delhi: Sage Publications.
 - ii. **Journals:** Batley, R. 2004. The Politics of Service Delivery Reform. *Development and Change* 35 (2): 31-56.
