- Form-G is to be filled in 07 sets. 07 copies of approved synopsis and 07 copies of all educational certificates, passport etc. is also required with Form-G. This form will be signed by Head and Dean/Director of the concerned department/faculty/Centre, Foreign Student Advisor and Registrar, JMI.
- In case of Visa conversion from Student Visa to Research Visa, FORM-G may submitted to FRRO Delhi. Otherwise, the applicant should submit the same to the Indian Embassy in the parent country of the candidate.
- Final admission to Ph.D. programme shall be given on PRODUCTION OF RESEARCH VISA.
- A fee of US \$ 1200 per annum shall be charged, if admission is given.
