In order to be eligible to appear at the Annual/Semester End Examination, a student shall be deemed to have undergone a regular course of study in the University, if he/she has attended at least 75% in lectures/tutorials, AND separately 75% in practicals/ field work/teaching practice and/or such other activities as decided by the Academic Council from time to time. Provided that a relaxation to the maximum extent of 10% of the total attendance may be accorded to a student on account of serious sickness/excruciating medical disability*, participation in the university-approved co-curricular/extra-curricular activities and prescribed educational/cultural tours.
