
NOTIFICATION

The Offg. Vice-Chancellor, JMI on behalf of the *Majlis-i-Talimi* (Academic Council) has approved adoption and implementation of UGC's directives issued vide Public Notice No. F.9-1/2020 (PS/Misc.) dated 06.03.2024 regarding eligibility criteria for promotion under CAS in terms of guiding Ph.D. Scholars. It will be implemented in the University from the academic session 2024-2025.

Consequent upon adoption and implementation of the above UGC's directives in the University, the para 5 (a) of the Ordinance - IX (Academic) has been amended as given below:

Para	Existing provision	Amendment
5(a)	<p>The allocation of supervisor for a selected scholar shall be decided by the DRC/CRC, on the basis of available faculty members who have vacancies and possess the requisite specialization in the research area of the scholar. The DRC/CRC may not recommend any candidate whose specialization's teacher is not available.</p> <p>Also, the faculty members i.e., Professors / Associate Professors and Assistant Professors on probation will not be appointed the Supervisor of Ph.D. candidates.</p>	<p>-No Change-</p> <p>Eligible Permanent faculty members can guide Ph.D. scholars during their probation period also.</p>

The action taken by the Offg. Vice-Chancellor, JMI will be reported to the Academic Council in its forthcoming meeting.
