**Ordinance 26 (XXVI) (Academic)
"Re-Employment of Superannuated Teachers"**

Para No.	Existing Provision	Amended
6	<p>Duties and Responsibilities:</p> <p>A re-employed teacher shall be treated at par with other regular teachers in the university in academic matters and shall perform following responsibilities:</p> <p>a) Academic work, like teaching courses, conducting examinations and research guidance,</p> <p>b) Conducting research and/or taking up sponsored research projects,</p> <p>c) Organizing conferences, symposia, workshops etc. without any financial implication.</p> <p>d) Participation in academic/ research committees at the university where appointed and elsewhere, whenever required.</p> <p>Note: A re-employed Teacher shall not be eligible for holding administrative or financial responsibilities such as Head, Dean, Member of any authority of the University etc.</p>	<p>Duties and Responsibilities:</p> <p>A re-employed teacher shall perform the following responsibilities:</p> <p>a) No Change</p> <p>b) No change</p> <p>c) Organizing conferences, symposia, workshops etc. in consultation with the Competent Authority and without being given any financial responsibility, provided it is recommended through proper channel.</p> <p>d) No change</p> <p>Note: No change</p>
