<p align="center"><b>5.1.3</b></p>	<p>For the programmes listed in Annexure 15A-1, the lowest passing grade in a course and also for awarding a degree will be 'C' and a candidate having obtained the 'D' grade in a course shall be declared as failed in that particular course.</p> <p>For the programmes listed in Annexure 15A-2, the lowest passing grade <u>in a course, based on the combined marks of Internal Assessment and Semester-End Examination</u>, will be 'C<sup>+</sup>', and a student having secured a grade lower than this shall be declared as failed in that course.</p>	<p>(i) For the programmes listed in Annexure 15A-1, the lowest passing grade in a course and also for awarding a degree will be 'C' and a candidate having obtained the 'D' grade in a course shall be declared as failed in that particular course.</p> <p>(ii) For the programmes listed in Annexure 15A-2, the lowest passing grade <u>in the Internal Assessment as well as in the Semester-End Examination of a course</u> will be 'C' separately for each component, whereas the <u>combined marks of Internal Assessment and Semester-End Examination</u> will be 'C<sup>+</sup>', and a student having secured a grade lower than this shall be declared as failed in that course.</p>
