2.7	For computation of SGPA (Semester Grade Point Average) and CGPA (Cumulative Grade Point Average), the grades obtained by a student in 'compulsory' courses shall not be counted.	For computation of SGPA (Semester Grade Point Average) and CGPA (Cumulative Grade Point Average), the grades obtained by a student in 'compulsory' courses shall (unless otherwise expressly provided for) not be counted. Provided that in the case of Complulsory Urdu as well as General English courses taught in each semester, the grades obtained by a student shall be counted for computation of SGPA and CGPA.
