## A brief about Dalits

- Caste is not merely a principle of social division but a comprehensive system of life.
- The caste Hindus' unquestioned social supremacy were consciously given a religious sanction.
- Dalits were treated as a conquered slave community without even ordinary human rights.
- Population : 320 millions as pan-Indian community
- 20 millions in Andhra Pradesh and Telangana states.

## Hypothetical assumption

- There is something deficient about "equality" if a quarter of the population is missing from the Fourth Estate.
- Is media democratizing its content, order and communication?

## **Objectives of the study**

- To understand the diversity in media newsroom production, mainly content analysis.
- To understand the cultural diversity within the media organization (levels of participation).
- To explore the reproduction of caste hegemony in television newsrooms.

### **Theoretical framework**

- 'Power as domination, it reproduces itself in different locations and employing similar apparatuses, strategies and mechanisms of control'
- How 'we are seen determines in part how we are treated; how we treat others is based on how we see them [and] such seeing comes from representation'.
- Representation as constitutive, having the power to establish or give organized existence to something.
- The spirit of Indian constitution upholds 'one man one value'

## **Research methodology**

- **Time window:** One month (15<sup>th</sup> Dec 2013 to 15<sup>th</sup> Jan 2014).
- **Quantitative**; content analysis i.e. systematic random sampling.
- Alternative day samplings (15 samplings from each channel)
- Prime time; 8:00pm and 9:00pm (TV9 & ETV)
- Number of news items for the one month
- **Qualitative analysis;** snow-ball sampling, in depth interviews.
- Unit of analysis: 14
- The respondents are employees of Etv and Tv9, Dalits & Non-Dalits

## **Findings : Participation**

- Unit of analysis: 14, Dalits (6) & Non Dalits (8)
- No cultural diversity network in the both channels
- Caste-connectivity in the recruitment & promotions
- Reflecting political inclinations
- Homogenization of representation
- No participation from below
- No women in both channels from Dalit community

- Indian Aparthied by Chandrabhanu Prasad (2007)
- MRPS (2008) challenge made revisiting Dalit participation in media in AP
- The social relities:
- Every day:
  - 3 Dalit women are raped
- 2 Dalits are murdered & 2 Dalits Houses are burnt in India
- 11 Dalits are beaten
- Every week:

- 13 Dalits are murdered
- 5 Dalits home or possessions are burnt
  - 6 Dalits are kidnapped or abducted
