## About The University

Jamia Millia Islamia, was originally established at Aligarh in United Provinces, India in 1920. It became a Central University by an act of Parliament in 1988. In Urdu language, Jamia means 'University', and Millia means 'National'. It is a central university located in New Delhi. In the list of the Faculties, i.e. Education, Humanities & Languages, Natural Sciences, Social Sciences. Engineering & Technology, one more Faculty, the Faculty of Law, was added in 1989. Many new courses and programmes at UG and PG levels have since been added. Besides its nine faculties, the Jamia has a number of centres of learning and research, like the AJK-Mass Communication Research Centre (MCRC), Academy of International Studies etc. Presently, Jamia is marching ahead in the field of Information Technology (IT). It offers various undergraduate and postgraduate IT courses. Apart from this, Jamia has a campus wide network which connects a large number of its departments and offices.

# About The Department

The Department of Social Work was established in 1967 to impart Social Work education at under-graduate level and subsequently in 1976 the post-graduate programme in Social Work was introduced. It has been in the forefront of academic and field innovations in the country and has been consistently upgrading its curriculum to make it more responsive to the social challenges in India. In the year 1991, the department was accorded the status of Department of Special Assistance (DSA) by the University Grants Commission (UGC) that was followed by two more phases of DSA. After the three phases of special assistance, in 2010, the UGC recognized the Department as a Centre for Advanced Study in Social Work. The department was also sanctioned assistance from UGC under the ASIHSS programme (2005-2010). The DSA and ASIHSS put together have strengthened the department in terms of academic quality and infrastructure building. The department is well known for its teaching and instructional programme as well as innovative field action projects. It boasts of first rate highly qualified and

field grounded faculty. It maintains a progressive and people centred emancipatory focus in its pedagogy, research and field action. The teaching faculty is constantly engaged in advanced research and field action projects to inform its instructional programmes. Members of the faculty also serve on various committees for the formulation, monitoring and implementation of development initiatives, both in the government and the NGO sector. Several high quality publications from reputed publishers have been produced by members of the faculty. The department also boasts of excellent infrastructure in terms of smart class-rooms, a modern conference room, well stocked seminar library, a computer and data processing laboratory and an advanced behavioural and personality enrichment laboratory.

#### Dr. NEELAM SUKHRAMANI

Dr. Neelam Sukhramani, an Associate Professor at the Department has obtained her Masters in Social Work from Tata Institute of Social Sciences. As part of her doctorate from Jamia Millia Islamia she studied the issue of NGO accountability from a multiple stakeholder perspective. While the organizations that formed part of her study were those working with street children, the usage of instrumental case study design enabled her to draw accountability indices for other organizations as well. Dr. Sukhramani has also completed her Bachelor's degree in Law from Delhi University. She has undertaken several other research projects on the issue of child protection. She has not only undertaken research on her own in this domain but also been a research advisor to other child protection funding and implementing agencies. The areas on which her doctoral students are currently working include survivors of intra-parental violence, gender constructs of women police officers, life after release for children in conflict with law, resilience among women widowed due to conflict, change in livelihood patterns due to HIV/AIDS. She is also the academic director for the project on Institutional Capacity Building for HIV and AIDS counseling (Saksham) which is supported by Global Fund and is running in India under the aegis of Tata Institute of Social Sciences. In the realm of capacity building, she has been instrumental in developing several modules for HIV counseling. She has also compiled five modules for strengthening life skills among university students. Training on skill building in the area of counseling has been undertaken by her with varied groups of professionals. Her publications include both experiential and research based articles. Based on her training experiences in the area reproductive and sexual health, she has published a handbook for young adults.

#### Dr. ARCHANA DASSI

Dr. Archana Dassi has been awarded the UGC Research Award in the year 2014. Her area of Research is Gender and Violence with special reference to Domestic Violence. #### THRUST AREAS FOR RESEARCH

The Department became the Centre of Advanced Study (CAS) in 2010. Under CAS the broad focus areas have been Social Development and Human Resource Management, with special reference to Capacity Building, Disaster Management and Women Empowerment. Flowing from these focus areas, certain areas have emerged as the thrust areas of research promoted by the department. These mainly are:

- Education and continuing education
- HIV/AIDS
- Public health
- Child Rights
- Corporate Social Responsibility
- Livelihood Issues
- Adult Literacy
- Resilience, Coping and Conflict Mitigation
- Ageing

#### LEVELS OF RESEARCH

Research is promoted at various levels in the department. These are at the field level, policy level, evaluative research projects, post doctoral research, doctoral level and masters level. The Department promotes research at each level, so as to inculcate the skills and altitudes among students, research scholars and faculty members. The Research Components are incorporated at different levels and are described below:

Masters level: Both M.A Social Work and M.A Human Resource Management students undertake minor research studies under the guided Supervision of their field work Supervisors. These Dissertations are marked and evaluated both by Internal supervisors and then by External Examiners in a Viva-Voce. The students learn to carry out Research, formulate Research Designs, prepare tools, analyze and interpret data and write dissertations. Some of the major themes that have been covered in the Social Work dissertations are Gender and Sexuality, Education, Livelihood, Mental Health, Ageing, Drug Abuse, HIV/AIDS, and Homelessness. In HRM, students' dissertations have covered themes like Bench Marking, Training and Development, Talent Management, Human Resource Audit, Job Satisfaction, Work Life Balance, Employment Engagement etc.

**Doctoral Research:** The students of Doctoral Research are given intensive inputs on quantitative and qualitative research methods as part of their course work. Within this, they also undertake a minor research study on the theme area of their Doctoral research. The Department has continuously facilitated research in areas relevant to contemporary Social Work practice and Human Resource Management. In recent years Doctoral research in Social Work and HRM has covered themes such as Livelihoods, Training, Communication, Quality of Life, Skill development, Community participation, HIV and AIDS, Women Empowerment, Domestic Violence, Self Help Groups, Entrepreneurship, and CSR. Guiding doctoral research leading to the award of the degree of Doctor of Philosophy in Social Work (Ph. D.) is one of the activities carried out by the faculty members. The students are required to submit six monthly progress reports and make progress presentations and a Presubmission presentation. These research colloquiums help all research scholars to review their work and have an understanding of research methodologies used by others. Students and faculty members together attend these.

The list of ongoing and completed Doctoral Research is given in Table. No 4 and 5.

**Post Doctoral Research:** Postdoctoral Research in the Department offers wonderful academic, administrative and teaching opportunities to aspiring and potential young scholars from a wide array of subjects in Social Sciences. It also provides platform to participate in conferences, symposiums and seminars, and interact with researchers and collaborate with universities from around the world. At the Post Doctoral level the thrust research areas that got visibility and these are HIV/ AIDS, and Public Health. The Post Doctoral research on HIV/ AIDS is an action research with 400 male migrants working in the unorganized sector in Haryana. The other research carried out at the post doctoral level is on Occupational Health with special focus on the workers of Organized and Unorganized sector in India.

**Short Term Programmes in Research Methodology:** The Departments has endeavored to inculcate advanced level research skills among professionals and senior researchers. In this direction, the department organized two major training programmes.

- A ten days short-term course on Research Methodology sponsored by the Indian Council of Social Science Research (ICSSR) was organised.
- The department also organized Indian Association for Social Sciences and Health (IASSH) sponsored third pre-conference workshop on Approaches to Social Sciences Research, in collaboration with Centre of Social Medicine and Community Health, JNU and Indian Association of Social Sciences and Health.

These workshops/trainings were attended by 80 Scholars. They were from diverse disciplines such as Economic, Psychology, Sociology, Social Work, Population Studies, Management, Demography and Public Health.

**Projects Research:** As shown in Table 1 to 3, the faculty members have been actively engaged in both minor and major research projects funded by National and International funding agencies. These projects have been conducted regularly at State, National and International levels. The projects usually are structured so as to train young research professionals and create resources for the Department. Several reports, research papers and books have been produced from these research projects. These Projects have helped

to further our understanding of several issues falling in the thrust research areas. To name a few, these are Capacity Building, Counseling, Need Assessment of Occupational Health Infrastructure, Child Rights, Ageing, Health and CSR. The Department now envisions to develop:

- Teaching materials including case studies
- Policy briefs
- Training\_ and development materials for mid\_term career professionals
- Develop IEC materials
- Publish research papers and books.
