



MEMORANDUM OF UNDERSTANDING

between

JAMIA MILLIA ISLAMIA, NEW DELHI, INDIA

and

AL-QUDS UNIVERSITY, JERUSALEM, PALESTINE

The purpose of this Memorandum of Understanding (MoU) is to promote scholarly exchange and cooperation and students exchange between Jamia Millia Islamia, and Al-Quds University. The parties recognize the value of educational culture, and scientific research between international research institutions, and have determined the sufficient interest exists to establish a formal relationship to develop programs, encourage the exchange of faculty, researchers, and students .

AND WHEREAS it is the statutory object of the Jamia Millia Islamia University and Al-Quds University to disseminate and advance knowledge by providing instructional, research and extension facilities in such branches of learning as it may deem fit and it shall endeavor to provide to students and teachers the necessary atmosphere and facilities for the promotion of:

- (i) Innovations in education leading to restructuring of courses, new methods of teaching and learning and integral development of personality.
- (ii) Studies in various disciplines.
- (iii) Inter disciplinary studies.
- (iv) National integration, secularism and international understanding.

NOW THEREFORE the Jamia Millia Islamia and the Al-Quds University have intended, agreed and consented to **following terms and deeds** in pursuance of a common intent to promote and develop the study of Cultural studies and Islamic studies.

1 FIELD OF COOPERATION:

- a. Both institutions shall evolve a mutually acceptable schedule to develop programme, hold seminars and exchange visits.
- b. The said academic interaction and intellectual stimulation may include:
 - i. Faculty/Staff development and exchange;
 - ii. Exchange of Students;
 - iii. Seminars, research, conferences and workshops;
 - iv. Collaborations in the sharing of academic data's, scientific information, intellectual property, articles and publications;
 - v. Advice surgeries, placements and executive training;
 - vi. Other forms of cooperation which the two institutions may jointly arrange.

2. EXCHANGE OF STUDENTS/TEACHERS

- a. Reciprocal arrangements based and mutually acceptable terms shall be accomplished to give and impetus to collaborative research and joint projects. Teachers, researchers, guides and student of both the institutions shall be encouraged to work in tandem in the laboratories, workshops, faculties and departments of both the institutions.
- b. Issue relating to travel, boarding, lodging, miscellaneous expenses shall vary according to the rules, regulations and policies of both the institutions.

3. TWINING

Both institutions shall draft and sign a twinning agreement during the next two months of signing this Memorandum of Understanding. The twinning agreement in relation to Jamia Millia Islamia University, New Delhi, India will be governed by its statutes and the laws of India. Similarly the twinning agreement in relation to Al- Quds University, Jerusalem, Palestine will be governed by the rules and regulations governing Al- Quds University, Jerusalem, Palestine and laws of Palestine.

4. MISCELLANEOUS:

- a. The details for the efficacious implementations of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- b. The parties to this Memorandum may, by mutual consent, add modify, amend, delete, review or revise any term(s) and condition (s) of this Agreement.

- c. The Financial arrangements involved in the implementation of this Agreement shall be settled through consultation between the two institutions in respect of each program of cooperation.
- d. The intent and implementation of this Memorandum is **SUBJECT** to the policies of the respective States (in case of international agreements) and the laws of the land.
- e. This Memorandum of Understanding shall remain in force for period of 5 years from the date of its signature and seal, and may be terminated by either side by giving a six months Notice to that effect in writing. However, notwithstanding the Notice of the intent to terminate the Memorandum, all rights, obligations and corresponding duties flowing and subsisting therein shall be respected and mandated till the finalization and accomplishment thereof.
- f. The parties to this memorandum of Understanding undertake to treat as "confidential and privileged" all information shared by either party in terms of the present Memorandum of Understanding. The terms of Confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- g. This Memorandum of Understanding shall require the ratification of the competent academic/ executive body of both the institutions.


