INTERNATIONAL CONFERENCE On Gender, Migration, and the Indian Diaspora Historical Trajectories and Contemporary Realities

About the Conference:

People migrate for various reasons and gender clearly shapes why they migrate, who migrates, the social networks they use, how they integrate, the labour opportunities they have at the destination, and their relations with their country of origin. This migration process not only changes individuals' physical locations, but also influences cultural identity and social structure in both the country of origin and the destination country. The Indian diaspora formed through the migration of Indians over an extended period is one of the largest and the most dispersed diaspora's worldwide. Most individuals in the Indian diaspora are descendants of labour migrants shaped by historical patterns of movement. Millions of Indians were brought to work on sugar plantations in the Caribbean, Africa and the Indian Ocean in the late 19th and early 20th centuries under colonial systems of indentured labour. These movements created a significant network of Indian communities in many countries and led to migration after 1947 during the post colonial period driven by economic and professional opportunities.

Gender plays a crucial role in Migration. Women migrants have made significant strides in asserting *their* presence within the contemporary and historical *migration discourse* and *global mobility debates*. For a long time, *systemic* gender blindness or the neglect of women's presence persisted in Indian narratives on migration *across* policy priorities, *institutional frameworks* and academic discussions — resulting in a significant knowledge gap. As a result, women's voices, lived experiences, and *their* crucial role in the multi-dimensional success story of the Indian diaspora remained overlooked and under-acknowledged. Over time, however, a *gradual but transformative* discourse shift has taken place due to *intersecting* international and domestic developments, moving away from portraying women as stereotypical, victimised, muted figures to recognizing the *complex*, multi-faceted aspects of their agency across social, cultural, economic, legal, *and political spheres of the diaspora*.

Women migrants have made significant strides in asserting *their* presence within the contemporary and historical *migration discourse* and *global mobility debates*. For a long time, *systemic* gender blindness or the neglect of women's presence persisted in Indian narratives on migration *across* policy priorities, *institutional frameworks* and academic discussions — resulting in a significant knowledge gap. Today, Women form the core and *dynamic heart* of the Indian diaspora and are indispensable to a comprehensive understanding of *migration processes* and diaspora formation. Women have participated in *virtually* all migratory movements that extended beyond Indian borders, and like the broader Indian diaspora, *women within it constitute a heterogeneous and diverse group shaped by intersecting identities of class, caste, religion, region, and age*. During the British colonial period, women began migrating from India under indenture systems and similar coerced labour arrangements, both as *dependents* and as independent migrants. It is historically documented that the colonial authorities *mandated* the transport of 40 women for every 100 men in indentured labour batches, *a policy aimed at stabilising settlement patterns and social reproduction* on plantations. These indentured women underwent *severe* exploitation in plantation colonies *through* coercive labour practices and patriarchal control *by both colonial authorities and male counterparts*. Nevertheless, their presence profoundly influenced Indian socio-cultural trends, *community formation*, political economy, *and early resistance movements* in plantation contexts. Contemporary scholarship has progressively

moved beyond stereotypical and objectified images of indentured women to explore the *multi-layered dimensions* of their agency, resilience, and active participation in shaping plantation life *and cultural continuity*.

Women continue to migrate in diverse capacities, including as spouses, *dependents and family units*, unskilled domestic workers, semi-skilled workers, skilled professionals, and highly skilled independent migrants. Many migrate as the primary breadwinners or economic anchors of their families, *Profoundly shaping livelihoods*, remittances, and *economic transformation* at both *micro and macro levels*. A substantial number of women continue to migrate as dependents, but within *family migration trajectories*, they frequently *exercise agency*, entering host-country workforces, albeit sometimes in roles that *do not fully reflect their qualifications or professional training*. In semiskilled and unskilled labour categories, women include domestic workers, caregivers, semi-trained medical personnel, *hospitality workers*, and others. Though such women display substantial decision-making power in both *household and economic spheres*, they often remain in *highly precarious* and disadvantageous positions due to limited labour rights, lack of legal protections, and social exclusion. *Consequently*, their restricted access to education, labour market information, *adequate legal representation*, and awareness about rights and privileges frequently leads to exploitative employment conditions and *prolonged separation* from families.

Highly skilled women migrants, including professionals in technology, academia, healthcare, *management*, and research, are comparatively well placed in the host-country job market and have greater capacity for socio-economic integration. However, many highly skilled Indian women *voluntarily or under persistent patriarchal cultural norms* prioritise domestic and caregiving responsibilities and therefore *often opt for part-time or informal employment*. This trend affects their labour market inclusion, perpetuates *gendered labour segmentation*, and *creates disparities in professional status vis-à-vis men*. *Structural barriers such as restrictive visa categories (for example, H-1B and H-4 in the U.S.) further constrain labour force participation for women migrants even when they possess advanced skills or qualifications*, leaving them in vulnerable or peripheral employment positions. Additionally, *women scholars and student migrants* represent a significant segment of highly skilled migration; India is one of the world's largest student-sending countries, and although female student participation has grown substantially, *systematic documentation remains limited*, pointing to an important research and data gap.

Women are also *among the most vulnerable* as trafficked and irregular migrants. These categories, irregular migration pathways, human trafficking networks, and undocumented work sectors, place women at *the highest risk of exploitation, abuse, and peril* during both the migration journey and in destination contexts. Another closely interrelated group within women migrants includes *left-behind spouses*, particularly wives whose partners migrate *ahead* in search of labour opportunities. One persistent concern raised in national discourse is the issue of *abandonment of left-behind wives or fraudulent marriages tied to migration*, which remain widespread in some regions of India.

Globally, women's migration patterns are shifting. In 2024, the number of women and girls among international migrants reached 146 million, accounting for 48% of all international migrants worldwide, reflecting *incremental progress in gender-balanced mobility and broadening global opportunities* for women's migration. Indian migration trends further underscore this shift. According to recent UN DESA estimates, women migrants from India account for 57.1% of all Indian international migrants, a significant increase from earlier decades, and a figure that *surpasses the female migrant share* in many regions. Despite this progress and increased scholarly attention, gendered aspects of migration, including wage discrimination, unequal labour rights, and intersecting forms of discrimination, remain central challenges within international, regional, and national policy spaces.

As a consequence of these developments and the growing global feminisation debate, women's migration issues have moved from the margins to *central positions in academic, policy, and institutional discourses*, including those led by the UN, IOM, and other multilateral organisations. Yet a pressing need remains for *comprehensive policy frameworks*, enforced protections, and empowerment strategies that address *the intersecting vulnerabilities* faced by women migrants. Female migrants frequently experience *double discrimination* — as migrants and as women within host institutions and societies, and women's migration remains comparatively understudied, especially in intersectional, longitudinal, and comparative research paradigms.

The proposed conference seeks to bring all these interlinked aspects onto a single multidisciplinary platform and to generate new theoretical, empirical, and policy-relevant approaches that amplify the subjective and lived voices of women in the Indian diaspora. By capturing the complex processes of women's migration and settlement across colonial and contemporary periods, the conference aims to map struggles, transformational.

experiences, structural barriers, and forms of agency that shape women's trajectories. The conference will draw on *diverse disciplinary perspectives, field research, and comparative insights* to advance new scholarship that meaningfully engages with women's roles, contributions, and challenges within diaspora contexts. The *resulting edited volume and policy briefs* will showcase innovative scholarship, address *significant knowledge gaps*, and serve as a global advocacy platform that amplifies women's voices and promotes gender equality in migration governance.
