About the Conference (JICE-2022)

The conference aims to invite intellectuals and researchers working in the area of Teacher Education across the world to discuss and deliberate on various aspects of teacher education curriculum, pedagogy, assessment, and the emerging prospects, concerns, issues and challenges. The very purpose of this conference is to envision the outcome-based curriculum and the required changes in the pedagogical and assessment tools, which will be required to prepare sincere, competent, skilled and humane teachers in the Post-COVID Era, which is being sensed, perceived and predicted to have a new social order with great changes in all walks of life after the gap of two-years of Pandemic.

For the past two and half years, the whole system of education at all levels has been highly disturbed. School education and the school going children are the most affected strata of the whole education system. Children have forgotten the basics that they had learned before the pandemic, their habits have got disturbed. It is predicted that if the situation does not come to normal soon, then the after-impact will be so huge and immense that its shocking waves will have to be faced by the society for years and centuries to come.

In the meantime, the National Policy on Education (NEP) 2020 was announced by the Government of India. The policy is highly visionary in nature and promises to change the

educational scenario of the country. It has restructured and rewritten the pattern of school education in India and modified it to 5+3+3+4 system from the previous 10+2 system by adding 3 years of pre-schooling into it, and aims to bring remarkable changes in curriculum, pedagogy, assessment at all levels of school education, in addition to the vast changes in higher education which now includes teacher education, professional education, and vocational education as well.

NEP-2020 focuses on the need for a holistic, integrated, enjoyable, and engaging curriculum and pedagogy. It suggests to reduce curriculum content to enhance essential learning and critical thinking, experiential learning, empowering students through flexibility in course choices, and also considers the significance of multilingualism and power of language; and the need of transforming assessment for students' development with a focus on 360-degree assessment and report card; in addition to so many other focal points in the policy.

In the post-COVID era, teachers and students of the whole world, especially at school level are required to be ready to face the aftermath challenges in all aspects of the teaching-learning process. Indian teacher education, teacher educators, school teachers are in much dire need to look into the concerns related to their teaching profession to cope up with the upcoming and ongoing challenges, and to be ready to implement NEP-2020 and contribute effectively in the process of recuperating from COVID-effects and in the making of New India and the New World.

Objectives: The objectives of organizing this international conference are:

- To bring the intelligentsia on a common platform to discuss and deliberate on various pertinent issues regarding teacher education and school education at global level.

Guidelines for Paper Contributors

Authors are requested to take care of the following guidelines before submission of the research paper to JICE-2022:

1. Submit original papers only; which have never been published or sent for publication to any other publisher.
2. Use Times New Roman for the entire manuscript with specific font sizes for different parts and headings of the paper (as given below).
3. Word limit for the full paper: 2500 to 3000 words (Maximum 10 to 12 Pages)
4. Title of the Paper: Font 14, Center text and bold
5. Abstract: Font 12, Italics, word limit-around 200 words
6. Key words: 5 to 7
7. All headings with font size 13 in bold
8. All subheadings in font size 12 in bold
9. Body text/running text in font 12 un-bold
10. Conclusion/Summary: Font 12, Italics, 200 to 300 words
11. References and Bibliography: APA format
12. Diagrams/graphs/figures: Properly placed and cited in the text with figure labels/description at the bottom of the diagram/graphs/figures/sketches etc.
13. Tables: Properly placed and cited in the text with table number and labels at the top of the table.
14. The factual information adopted from any of the published documents must be cited with source. In addition, this citation must be referred to in detail in the reference list.
15. Name of the contributor(s), designation, institutional affiliation, mobile number, and email-id must be given properly, preferably on the first sheet of the paper.
16. Copyright issues must be taken care of. The manuscript must be free from plagiarism.
17. Authors are required to submit a Certificate of Originality and Copyright Transfer Certificate to the publisher/editor(s), in the given format (Page-9). **Without submission of the certificate, the paper will not be included in the Proceedings/ Compendium/ Book to be published with ISBN No .**
