### CORRIGENDUM

In pursuance to the Judgement (dated 22.2.2011) of the National Commission for Minority Educational Institutions [Case No. 891/2006 and other connected Petitions] declaring Jamia Millia Islamia as a Minority Institution, the Ordinance 6 (Academic)(VI) has been amended in terms of Statute 39 of the Jamia Millia Islamia Act, 1988.

As a consequence thereof, the reservation of seats for admission to all the courses from the academic session 2011-12 onwards shall be as under:

- A) i) 30% of the total number of seats in each course shall be earmarked for the applicants who are Muslims;
- ii) 10% of the total number of seats in each course shall be earmarked for the Women applicants who are Muslims;
- iii) 10% of the total number of seats in each course shall be earmarked for the applicants of "Other Backward Classes" (OBC) and Scheduled Tribes who are Muslims [as per the notified list of the Central Government].
- B) 3% seats in all courses shall be reserved for physically challenged persons in accordance with the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995.
- C) 5% seats in all undergraduate/diploma courses shall be filled by internal students of Jamia who have passed their qualifying examination from the Jamia Schools as regular students, subject to the condition that such applicants must have been on the rolls of the Schools(s) for a continuous period of five years.

The amended Ordinance as also the detailed conditions regulating the admissions in the above said categories have been posted on the Jamia website at [www.jmi.ac.in](http://www.jmi.ac.in). All the candidates who have applied for admission to various courses offered by Jamia Millia Islamia are advised to carefully peruse the Ordinance and other related notifications. Candidates appearing in the admission tests shall be compulsorily required to fill-up a prescribed proforma to indicate afresh the category in which they seek to be considered for admission. No change or revision of the category will be permitted subsequently (except in cases listed at Notes 1,2&3, below).

Revised categories with their respective codes superseding the categories mentioned in the application forms are as under:

G	-	General
M	-	Muslims
MW	-	Muslim Women
MO	-	Muslim OBC
MT	-	Muslim Scheduled Tribe
PD	-	Persons with Disability
J	-	Candidates Qualifying from Jamia Schools

#### Note:

1. The candidates seeking admission to various courses offered by AJK Mass Communication Research Centre should indicate afresh the category in which they would like to be considered for admission either at the time of entrance test or latest by 25<sup>th</sup> May 2011 through the prescribed Proforma.
2. Applicants for admission to M.B.A. (Full-time) should indicate afresh the category in which they would like to be considered for admission either at the time of entrance test or latest by 19<sup>th</sup> May 2011 through the prescribed Proforma.
3. Applicants for admission to various classes in the Jamia schools should indicate the reservation category afresh by filling up the prescribed Proforma duly signed by the candidate and parent(s)/ local guardian and submit the same to the office of the school concerned latest by 31<sup>st</sup> May 2011.
