

Para 2	<p>Admission Procedure </p> <p>(i) Candidates who have qualified UGC/CSIR NET/ JRF examination or any other equivalent examination conducted by the recognized Governmental Department/ Institute/ Agency/ SLET/ <u>valid GATE</u> with minimum score of 65, or having successfully completed regular M.Phil. programme of two years duration from a recognized university/institution.</p>	<p>Admission Procedure </p> <p>(i) Candidates who have qualified UGC/CSIR NET/ JRF examination or any other equivalent examination conducted by the recognized Governmental Department/ Institute/ Agency/ SLET/ <u>valid GATE Score (with qualifying marks)</u>, or having successfully completed regular M.Phil. programme from a recognized university/institution.</p>
Para 4		<p><i>Add the following sub-para:</i></p> <p>(vi) Where the Supervisor, by reason of illness, absence or any other cause, is unable to supervise the scholar, the Head of the Department/ Director of the Centre/ Dean of the Faculty concerned shall be deemed to be the Supervisor, till the Board of Studies/Committee of Studies appoints a new Supervisor.</p> <p>(vii) Where a faculty member, who is the Supervisor of a Ph.D. student registered under him/her, is shifted from one Department to another in the same Faculty or from one Faculty/Centre to another Faculty/Centre, the said student will be deemed to have been transferred to the same department in which the Supervisor has got shifted, subject to the completion of necessary formalities by the concerned Board of Studies/ Committee of Studies.</p>
