NOTIFICATION

The Executive Council, JMI, in its meeting held on 30.06.2026, on the recommendations of the *Majlis-i-Talimi* (Academic Council) in its meeting held on 23.06.2026, has approved the following in respect of the Ordinance - 9 (IX) (Academic) 'Degree of Doctor of Philosophy (Ph.D.)' with immediate effect:

(i) Amendment in Para 3 c. (i) as follows:

Existing provision	Amended provision
3 c. (i) Candidates who have qualified for fellowship/scholarship in UGC-NET I, II & III/UGC-CSIR NET/GATE*/CEED and similar National level tests.	3 c. (i) Candidates who have qualified for fellowship/scholarship in UGC-NET I, II & III/UGC-CSIR NET / GATE* / GPAT / CEED and similar National level tests.

(ii) In the para 3 h. the interview marks of 30% will be added.

(iii) A new Para (h) with the following text will be added in the Clause 6:

"(h) Faculty members with less than three years of service before superannuation shall not be allowed to take new research scholars under their supervision. However, such faculty members can continue to supervise Ph.D. scholars who are already registered until superannuation and as a co-supervisor after superannuation, but not after attaining the age of 70 years."

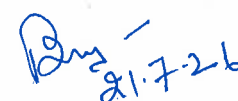
(iv) Deletion of typographical error from Para 3.f, which was inadvertently added in the agenda of the meeting of the Academic Council dated 23.06.2026. Now para 3.f of Ordinance - 9 (IX) read as "Criterion to Qualify the Entrance Test: Only those candidates who obtain at least 50 per cent marks in aggregate shall qualify for the interview."
