Amendment in Ordinance 5 (V) [Academic] concerning "Admission and Enrollment of Students" vide E.C. Resolution No. EC-2012 (I): Reso-13.1 dated 23.01.2012

<u>Existing Ordinance 5 (V)</u>	<u>Amended Ordinance 5 (V)</u>
<p>Para 5.1</p> <p>A student of any course who could not appear in the examination due to shortage of attendance or any other reason or who fails in the examinations, may be given re-admission in the same class of that course in the next academic session.</p>	<p>Para 5.1</p> <p>A student of the 1st Year/1st Semester of any course who is detained due to shortage of attendance will no longer remain a student of the University. Such a student will have to seek fresh admission and will be required to go through the entire admission process. Provided that a student of 1st Year/1st Semester of any course who fails in the Annual/Semester-end Examination or who could not take the examination for reasons other than shortage of attendance, will not be readmitted. However, he/she may be allowed to appear as an Ex-Student in the consecutive Annual/1st Semester-end Examination.</p>
	<p>Para 5.2</p> <p>A student of other than 1st Year/1st Semester, who has not taken the examination due to shortage of attendance, may be given re-admission in the said class of that course in the next consecutive Year/Semester. In case, the student fails to fulfill the requirement of attendance after being given re-admission, his/her admission shall stand cancelled.</p>
