***Amended Clause (1) of Statute 22-A captioned "Centres"
as approved vide MHRD No.F.6-9/2009-Desk(U)
dated September 23, 2009***

1. Supplement to Statute 22, the University shall also have the following Centres, namely:
 - (i) Dr. Zakir Husain Institute of Islamic Studies;
 - (ii) FTK-Centre for Information Technology;
 - (iii) Maulana Mohammad Ali Jauhar Academy of Third World Studies;
 - (iv) Centre for Distance and Open Learning;
 - (v) Centre for Management Studies;
 - (vi) Nelson Mandela Centre for Peace & Conflict Resolution;
 - (vii) Centre for Jawaharlal Nehru Studies;
 - (viii) Centre for Comparative Religions and Civilization;
 - (ix) Centre for West Asian Studies;
 - (x) Dr. K.R. Narayanan Centre for Dalit and Minorities Studies;
 - (xi) Centre for Spanish & Latin American Studies;
 - (xii) **Centre for Physiotherapy and Rehabilitation Sciences;**
 - (xiii) **Academy of Professional Development of Urdu Medium Teachers, AND**
 - (xiv) Such other Centre(s) as may be prescribed by these Statutes.
2. Subject to the provisions of the Act and these Statutes, each Centre shall function under a Board of Management, the composition, powers and functions of which shall be as prescribed in the Ordinances of the respective Centres.
3. Each Centre shall have a Director, who shall be appointed in accordance with the provisions of the relevant Statute; and shall enjoy such powers and perform such functions as prescribed by the Ordinances.
