NOTIFICATION

Subject: Corrigendum to the Minutes of the Executive Council Meeting dated 30.09.2025 – Agenda Item No. 08

It is hereby notified that the minutes recorded under **Agenda Item No. 08** of the Executive Council meeting held on **30.09.2025** are corrected as follows:

"The Majlis-i-Muntazimah (Executive Council) has noted the anomaly in the Resolution No. 14 dt. 18.08.1977 whereby permanent employee(s) of Jamia Millia Islamia is/are appointed/promoted on another post of the same Department w.e.f. the next date of the Selection Committee and also noted that there is no provision in the Govt of India (DoPT) Rules to allow a person to join duties from the next date of Selection Committee. Normally, a person should join his duties on or after the date of issuance of appointment letter and his seniority shall be counted with effect from the date of his/her joining.

In view of the above, the House unanimously resolved that henceforth the appointment of a teaching employee against an open post under direct recruitment (internal as well as external) shall be effective from the date of his/her joining and seniority shall be determined in accordance with the UGC Regulations and the applicable Government of India rules.

And the appointment of a non-teaching employee against an open post under direct recruitment (internal as well as external) shall be effective from the date of his/her joining and seniority shall be determined in accordance with the UGC CRR-2022 and the applicable Government of India rules."

The above shall be read as the correct resolution of the Executive Council in respect of Agenda Item No. 08.
