**Ordinance 5 (V) [Administrative/General]
"LEAVE RULES APPLICABLE TO TEACHERS"**

Para No.	Existing	Amended
8.		<p>To add the following provisions as sub-para (v) to para 8 "Extra Ordinary Leave":</p> <p>(v) EOL granted to staff for short-term/long-term assignments in India or abroad may be regulated on Foreign Service Terms (FST) for the purpose of annual increments (notional) and terminal benefits. Pension and Leave Salary Contribution as per CCS rules shall be paid either by the employer or by the employee concerned to JMI for the period of Foreign Service mandatorily. These contributions will entitle the employee to count his/her period of Foreign Service towards pensionary benefits, annual increments and earned leave/half pay leave. However, such period of EOL will not count towards continuity of service for Sabbatical Leave Eligibility. The contribution towards Leave Salary and Pension Contribution has to be paid at the end of every financial year failing which it attracts interest as per SR-307 (1).</p>
