Student during the first and second semesters of the programme shall be judged on the basis of his/her class attendance, performance in <u>Internal Assessment and/or the Semester-End Examinations, as the case may be.</u> A student who is short of the requisite attendance or is unable to secure at least 50% marks or equivalent grade <u>in Internal Assessment/ Practical / Field Work/Teaching Practice etc., or has failed in the M.Phil. 2nd semester examination and is not promoted to the 3rd semester,</u> his/her Non-NET fellowship shall be discontinued. Such a student will not be entitled to get the said fellowship even after he/she is re-admitted to the next semester of the M.Phil. programme.</p>	<p>2.3. Modalities for Non-NET Fellowships for M.Phil. Students</p> <p>(ii) The progress of an M.Phil. Student during the first and second semesters of the programme shall be <u>assessed</u> on the basis of his/her class attendance <u>and</u> performance in the <u>1st and 2nd Semester Examinations.</u></p> <p>A student who is short of the requisite attendance or is unable to secure at least 50% marks or equivalent grade <u>in any of the Courses of the 1st/ 2nd Semester Examination,</u> his/her Non-NET fellowship shall be discontinued. Such a student will not be entitled to get the said fellowship even after he/she is re-admitted to the next semester of the M.Phil. programme.</p>
