Existing Provision in Ordinance 1 (I) 2. The Shaikhul Jamia (Vice-Chancellor), Naib Shaikhul Jamia (Pro-Vice-Chancellor) and Musajjil (Registrar) shall be entitled to the benefits of the Contributory Provident Fund of the University. 8. If a person, employed in another Institution is appointed as Shaikhul Jamia (Vice-Chancellor) on Deputation, he/she shall be entitled to Salary, Allowances, Leave and

University shall also pay Leave Salary, Provident Fund, Pension Contributions to the Institution, where he/she is permanently employed, as admissible under the Rules.

9 (1). The Shaikhul Jamia (Vice-Chancellor) shall be entitled to have a furnished residential accommodation as may be approved by the University and free water and free power. He/She will pay prescribed licence fee. The premises of his/her lodging will be maintained by the University.
