NOTIFICATION

This is to notify for the information of all concerned that the President of India in her capacity as the Visitor of Jamia Millia Islamia has been pleased to accord her kind assent for the amendments to the existing Statute 13(1) & 13(2) of Jamia Millia Islamia Act, 1988 regarding inclusion of a representative of the Ministry of Education as a member in the Executive Council of the University and change in Quorum of the Executive Council, as conveyed by the Ministry of Education (Department of Higher Education) vide its letter F.No. 18-33/2025-CU.I dated 15.04.2026.

The amended Statute 13 as approved would be read as under:

13. MAJLIS-I-MUNTAZIMAH (EXECUTIVE COUNCIL):

(1) The *Majlis-i-Muntazimah* (Executive Council) shall consist of the following members, namely:-

- i. *Shaikh-ul-Jamia* (Vice-Chancellor), Ex-officio Member;
- ii. *Naib Shaikh-ul-Jamia* (Pro-Vice-Chancellor), Ex-officio Member;
- iii. **The Secretary (Higher Education), Ministry of Education, Government of India or his/her nominee, Ex-officio Member;**
- iv. Two Deans of Faculties by rotation according to seniority;
- v. Dean of Students' Welfare, Ex-officio Member;
- vi. One of the Directors of Board of Management, Centres of the University, by rotation according to seniority;
- vii. Three teachers – one each from amongst Professors, Readers and Lecturers of the University to be appointed by the *Shaikh-ul-Jamia* (Vice-Chancellor) by rotation according to seniority;
- viii. Four persons to be nominated by the Visitor;
- ix. Two persons from amongst the Life Members under Statute 11 (1) (xi) chosen by the *Anjuman* (Court) by rotation.

(2) **One-third (1/3rd) of the total strength shall form quorum for the meeting of *Majlis-i-Muntazimah* (Executive Council).**

- (3) All the members of the *Majlis-i-Muntazimah* (Executive Council) other than ex-officio members shall hold office for a period of three years.
