## (a) Summary of Courses Taught

# i. Teaching

# Graduate

# 1. Medical Terminology (4608215-2) - 2014 to present

This course for the second-year students will enable them to speak, use, and understand commonly used terms in the field of medicine. It emphasizes the building of a medical vocabulary from prefixes, suffixes, roots, and combining forms. Emphasis placed on correct pronunciation, spelling, and analysis of medical terms as they pertain to anatomy, physiology, and diseases. The course provides an organized method for unlocking the mysteries of medical terms and

building a working vocabulary through lectures, presentations and group discussions.

# 2. Legal Aspects of Health Care (4608223-3) - 2014 to present

This course for second year students provides a current and historical overview of the regulation of health care delivery. It examines principles and practical applications of the laws that affect the operational decisions of health care providers, payers, and managers and that impact development of markets for health care products and services. Also, considered are the social and ethical issues encountered in trying to balance the interests, needs and rights of individualcitizens against those of society. The focus of this course is to provide students with the practical knowledge to identify legal issues and to understand the legal ramifications of strategic decisions. Lectures, presentations and quizzes organized for better understanding of the legal issues concerning health care.

3. **Health Data Coding and Classification-I** (4608313-3); 2015 to present This course for third year students provides improvements and increasedefficiencies in the health care system and depends upon the collection, coding and classification of health data. Once captured in a standard format, health data is used to support management, planning and delivery of health services, research and education. The principles of data quality and the ICD-10-CM classification system, the current standard within Saudi Arabian hospitals and health facilities will be examined and applied in a component that includes working with the ICD-10-CM codes. Lectures, presentations and quizzes are organized for better understanding of the legal issues concerning health care.

# 4. Health Data Coding and Classification-II (4608321-3); 2015 to present

This course for third year students provides an understanding of how clinical information is collected, recorded and analysed in an electronic format. They would be able to ensure that data has been recorded accurately and understand theissues related to data quality. They will have an understanding of the majorcoding and classification systems used today. They will be able to read a patient record and understand the medical terminology in sufficient detail to adequately and effectively code a patient encounter using the ICD-10-CM codes. They were taught to use and monitor applications and work processes to support clinical classifications/coding. They will have the knowledge to adhere to current regulation and established guidelines in code assignment and validate coding accuracy for using clinical information found in the health record.

#### 5. Electronic Medical Records

This course for fourth year students is designed to introduce the student to the basics of medical records management. This course provides the student with the opportunity to put administrative skills learned in previous coursework into practice in a simulated medical setting using electronic health care records (EHR)

and allows the student to learn about EHR management practices. They will understand the medical billing process, including the flow of information from registering patients through recording office visit transaction to collecting on overdue accounts, the role of information technology in medical offices, and discusses the HIPAA Security Rule and the HIPAA Transaction and Code Sets Rule as they relate to insurance claims. Types of electronic management systems will be explored along with their impact on various areas of the healthcare system.

## 6. Fundamentals of Human Diseases, 4608323-3; (2015 to present)

The Human Health and Disease course is designed to bring students to a level of understanding of modern medical science. This course is an overview of acuteand chronic diseases and the role(s) of health professionals in their prevention, treatment and management. This course is designed particularly for health information management professionals for the basic knowledge of disease & disease pattern. Focus on diseases that are frequently first diagnosed and treated in the medical office setting. Students learn to recognize human body anatomy and the causes, signs, and symptoms of disease of the major body systems as well as the diagnostic procedures, usual treatment, prognosis and prevention of common diseases.

## 7. Introduction to Health and Hospital Management

This course is designed to give the student a complete overview of the health care system. This course introduces healthcare organizations and organizational management concepts. Designed to provide an overview of the management role, organizational theory, management economics, and theory and practice of systemic organizational change within overall strategic management and systemic contexts. This course also provides a broad overview of the various functions of the hospital and explores basic concepts of management theory as applied to hospital. Students will examine the administrative processes such as planning, problem solving, management of operations, financial management, human resource management, quality productivity improvement, and physician relations. Emphasis will also be placed on the major issues and problem areas confronting hospital administrators.
