- 1. The name of the medal will be in the memory of "Late Pt. Banarsidas Chaturvedi".
- 2. Gold medal will be given to a student of M.A. Convergent Journalism (total of 1<sup>st</sup> and 2<sup>nd</sup> year marks).
- 3. The name of the student shall communicated by the Controller of Examinations.
- 4. Dr. Apoorva Chaturvedi will send the medal every year for the next five years at a designated time thereafter a corpus money will be deposited in Jamia.
- 5. The value of medal will be 10 gms silver with 22 carat gold plating with 5 cm dia. The front of the medal will be **Pandit Barsidas Chaturvedi Award for Excellence in Print Media/Mass Communication** and reverse will be **Jamia Logo.**
- 6. The packing in an appropriate size red colour box laid with green velvet to hold the medal.

#### **Procedure of Selection**

- i) Student of M.A. Convergent Journalism with the highest marks (total of 1<sup>st</sup> & 2<sup>nd</sup> year marks) will be considered of the aforesaid medal.
- ii) Dr. Apoorva Chaturvedi would bear the cost of the medal.
- iii) Dr. Apoorva Chaturvedi may be invited at the time of the presentation of the award.

The first candidate did not seem to be interested from his approach/body language/lack of apology for coming late and appalling behavior to the members of the Committee. Dr. Sharma, the second candidate had experience limited only to broadcasting and was not having any experience of TV/Film making/animation/written journalism – the courses that run at the AJK MCRC. The third candidate, Prof. Shohini Ghosh was not interested as she has applied for leave to complete the Ph.D.

Since, Jamia has not been able to get suitable candidate for appointment as Director, AJK MCRC in spite of several advertisements and Search Committee process, the Majlis (EC) agreed to continue with present Officiating arrangement for a longer period upto three years or till regular selection is made as per provision of the relevant Statute, whichever is earlier.

The Report at **Annexure-VIII** was placed before the Majlis(EC) for considering the candidature of Mr. Shakti Sinha as Professor in the Nelson Mandela Centre for Peace & Conflict Resolution against the post vacated by Prof. Radha Kumar in terms of Statute 25 (8) of JMI Act, 1988, which inter-alia reads as under:

"......Notwithstanding anything contained in the forgoing clauses, the Majlis-i-Muntazimah (Executive Council) may invite a person of high academic distinction and professional attainment to accept a post of Professor in the University, on such terms and conditions as it deems fit, and on the person agreeing to do so, appoint him to the post."

The Majlis (EC) in its earlier meeting had approved private practice beyond duty hours to Medical Officers of Ansari Health Centre in lieu of grant of non-practicing allowance. The Ministry of Health and Family Welfare vide letter No. A.27023/1/2008-CHS.V dated 18.5.2010 (Annexure-X) have clarified that private practice is not allowed to CHS officers. The Majlis (EC), therefore, approved to withdraw the permission for private practice to Medical Officers of Ansari Health Centre. However, payment of non-practicing allowance as per Government rules will be restored.

### Approval of the relaxation in NET or equivalent/Ph.D. qualifications for appointment of guest faculty.

The Majlis(EC) considered UGC's proposal for the conditions for appointment of Guest Lecturers for short vacancies in technical/professional courses. It was noted that the University made its best efforts to get suitable candidates that would have a NET/SLET/Ph.D in the required discipline. However, despite best efforts, the University

was unable to get teachers with these qualifications, as a result of which the teaching schedule was severely affected. The University cannot further afford absence of guest lecturers if the respective courses are to be completed.

The Majlis (EC), therefore, resolved that the University relax the conditions for appointment of guest lecturers and to inform the UGC of the difficulties being posed in the selection process if the UGC guidelines are followed.

The Majlis(EC) further resolved that the UGC be requested that the guidelines should be relaxed to facilitate smooth functioning of classes.

Prof. S.P. Thyagrajan being a member of UGC Regulations Committee recorded his note of dissent.

Approval of the adoption of the UGC Regulations on minimum qualification for appointment of teachers and other academic staff in the Universities and measures for the maintenance of standard in higher education.

The Majlis (EC) considered the UGC's Regulations as contained in their letter No. F.3-1/2009 dated 30.06.2010 regarding minimum qualification for appointment of teachers and other academic staff in the Universities and measures for the maintenance of standard in higher education. Majority of members of the Majlis (EC) were of opinion that the procedure of selection contained in the Regulation quite cumbersome for which matter is being taken up with the UGC by the universities. The Mailis (EC) therefore, resolved that:

- (a) Qualifications as prescribed in Regulation may immediately be adopted.
- (b) Modalities of implementing the other parts of Regulation may be worked out by a Committee. Procedural difficulties to be pointed out by the Committee may be taken up with the UGC.
- (c) Necessary amendments in the Statutes and Ordinances based on Regulation may be framed after sorting out procedural difficulties by the UGC.

### EC-2010 (VI): Reso-16

<u>Decision on the request of Prof. Riaz Munir Ahmad regarding reinstatement in the light of Judgment of the Hon'ble High Court of Delhi dated 28.08.2009, 05.10.2009 & 07.12.2009.</u>

The Representation of Sh. Riaz Munir Ahmed was considered by the Majlis. It has been noted that the Applicant has been convicted of violation of penal laws under Sections 420 read with 120-B of the Indian Penal Code. He was sentenced to rigorous imprisonment for seven years and also fined Rs. One lakh by the learned Chief Metropolitan Magistrate vide an Order of conviction (dated 9.11.2004). The Applicant preferred an appeal before the learned Additional Sessions Judge in which the conviction of the accused (Sh. Riaz Munir Ahmed) was upheld although the Judge held that sentence awarded to him was on a higher side and was reduced to the period already undergone by him in prison. Thereafter, Sh. Riaz Munir Ahmed filed a Criminal Revision Petition in which he has submitted that although he has been convicted in criminal case, benefit be accorded to him under the Probation of Offenders Act. The said benefit was accorded to him by the Delhi High Court. It is pertinent to mention that Jamia Millia Islamia was not arrayed as a party in the said matters.

In Writ Petition (C) No. 33/2006 filed by him against Jamia Millia Islamia for reinstatement, disposal was done with a inter alia direction (dt. 7.12.2009) that the representation of Sh. Riaz Munir Ahmed be considered. Sh. Riaz Munir Ahmed has requested that in view of the benefit of the Probation of Offenders Act, he be reinstated with services (with dues and seniority).

It is to pertinent to mention here that his request regarding reinstatement in the light of the judgment of the Hon'ble High Court was also considered by the Majlis-i-Muntazimah (Executive Council) in its last meeting vide Reso. No. 7 dated 15.1.2010 and the Majlis-i-Muntazimah (Executive Council) had decided to file an appeal against the judgment of the Court order. However, the Legal Advisor had expressed reservations on the maintainability of such an appeal.

The Majlis (EC), after detailed deliberation, resolved as under:

- (1) Shri Riaz Munir Ahmed is not a fit person to be retained on the employment rolls of an educational institution as he was convicted by a court of competent jurisdiction and it is not a case of honorable exoneration. A teacher with a tainted record is unacceptable to teach young students.
- (2) His reinstatement shall be highly prejudicial to the academic environ of the University. Resultantly, no indulgence whatsoever can be granted to him in Jamia Millia Islamia.
