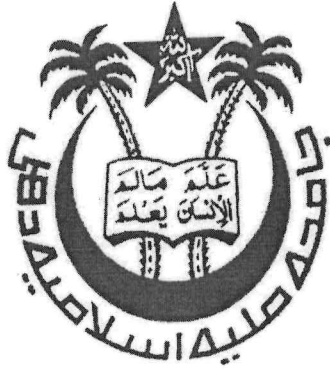

TO CONSIDER CONFERMENT OF HONORARY DOCTORATE (*HONORIS CAUSA*) UPON SHEIKH MOHAMMED BIN ABDULKARIM AL-ISSA, SECRETARY GENERAL, MUSLIM WORLD LEAGUE

DECISION

The *Majlis-i-Muntazimah* (Executive Council) considered and endorsed the decision taken by the Academic Council in its meeting held on 12.02.2026 to confer honorary degree of Doctor of Letters (*Honoris Causa*) in terms of Statute 29 of JMI Act, 1988 to Sheikh Mohammed Bin Abdulkarim Al-Issa, Secretary General, Muslim World League during his visit to India.

The House further directed that the requisite approval of the Hon'ble Visitor of the University be obtained in this matter. Upon receipt of such approval, the University shall confer an honorary degree upon Sheikh Mohammed Bin Abdulkarim Al-Issa. As Sheikh Mohammed is scheduled to visit India within 2–3 days following Eid-ul-Fitr, the limited timeframe does not permit for convening of a Special Convocation. Accordingly, a special function will be organized to mark the occasion.
