In view of the above, the House unanimously resolved that henceforth the appointment/promotion of a teaching/non-teaching employee (internal as well as external) will be effective from the date of issuance of appointment letter and his/her seniority will be counted w.e.f. the date of his/her joining on the post.

Therefore, Regulation XI is not in consonance with the UGC guidelines. Thus, the House has unanimously resolved to set aside Regulation XI to the extent that definition of a teacher shall only include Assistant Professor, Associate Professor and Professor. The retirement age of teachers i.e. Assistant Professor, Associate Professor and Professor shall be 65 years and no other category of staff shall be considered as a teacher as mentioned above. Further, the House has resolved that the retirement age of Research Assistant shall be 60 years in Jamia Millia Islamia in terms of the UGC guidelines. It was also resolved unanimously that all the instructors which will be appointed henceforth shall be considered as non-teaching staff and their terms of service shall be governed by the UGC guidelines.

The case of Mr. Shakeel Ahmad shall not be treated as a precedent and will have no bearing on other Research Assistants.

The House noted and approved the action taken by the Vice-Chancellor by suspending her for her unauthorized absence from duty and authorised the Vice-Chancellor to constitute a Committee and take appropriate action as per the recommendations of that Committee. It was also decided that the decision of the Enquiry Committee in this regard will be communicated to Ms Shagoofa Mushtaq.

**TO CONSIDER THE CASE OF MR. SUHAIL AHMAD, LDC (UNDER SUSPENSION) IN TERMS OF THE HON'BLE HIGH COURT OF DELHI, ORDER DATED 01.09.2025.**

**DECISION**

The House has perused and deliberated on the Order dated 01.09.2025 passed by the Hon'ble High Court of Delhi. *Majlis-i-Muntazimah* (Executive Council) in its meeting held on 30.06.2021 had terminated the services of Mr. Suhail Ahmad. The said action was pursuant to an Enquiry Committee which had submitted its report on 14.06.2021. Prima facie the House is of the opinion that the Enquiry Committee did not follow the procedure established by law. Hence the House, in compliance with the Order passed by the Hon'ble High Court of Delhi, recommends the enquiry from the stage of chargesheet. Mr. Suhail Ahmad shall remain under suspension and all the relevant documents shall be supplied to him.

The House has authorized the Vice-Chancellor to take appropriate action on the report to be submitted by Prof. Asad Malik, Faculty of Law, and Prof. Anisur Rahman, CWAS who have been appointed as Inquiry Officer and Presenting Officer to conduct disciplinary proceedings as per rule against Mr. Suhail Ahmad, LDC (under suspension).
