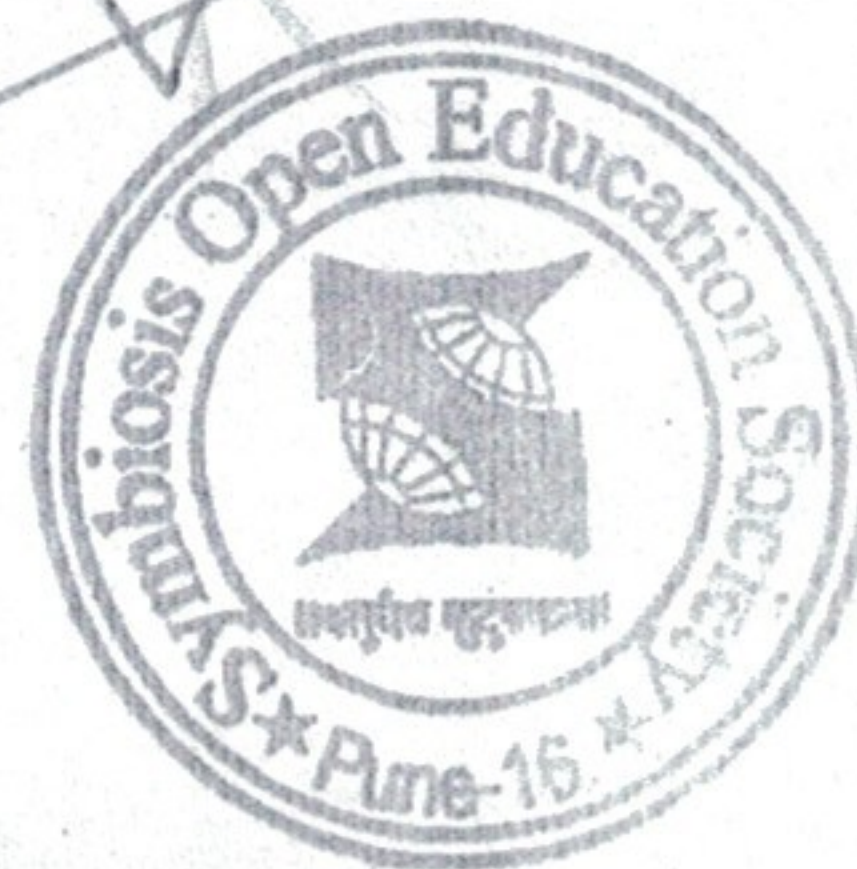

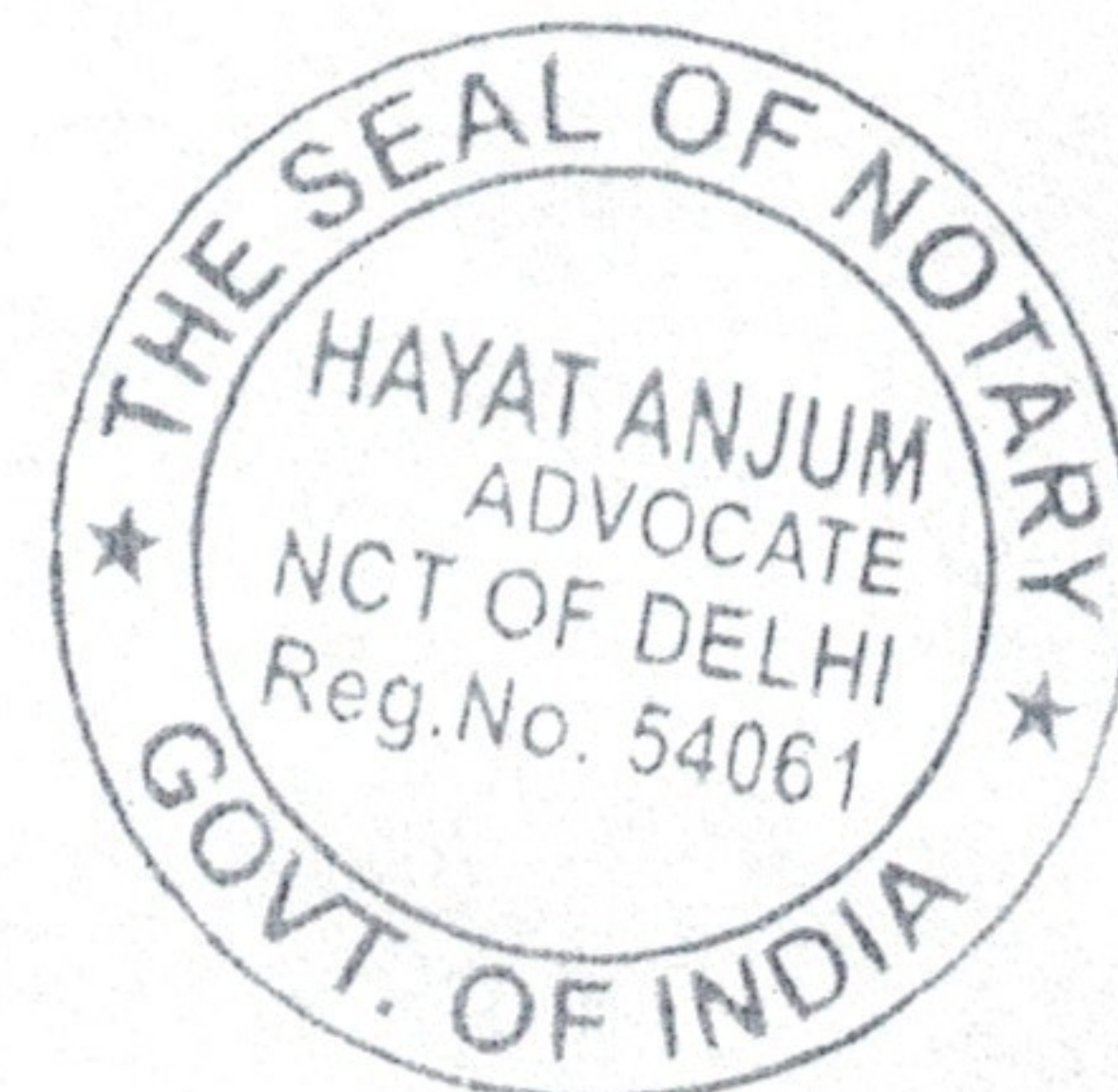

Preamble

This Memorandum of Understanding (MoU) is entered into by and between Symbiosis Open Education Society through its constituent **Symbiosis Skills and Professional University (SSPU)**, located at Village -Kiwale, Adjoining Pune Mumbai Expressway, Pune - 412101, Maharashtra State, India(referred to as "SSPU") and Department of Economics, Jamia Millia Islamia, located at New Delhi-110025, India (referred to as "Center"), and hereinafter collectively referred to as the "Parties."

Recognizing the mutual benefits of collaborations, the Parties agree to establish a cooperative relationship to promote academic, developmental, and socially relevant programs in Delhi.

Article 1: Objectives

The primary objective of this MoU as below:

1. Take various skilling programs offered by SSPU to beneficiaries through Center
2. Leverage SSPU's experience in impacting lives through skill training programs and your centres at various locations to implement training initiatives
3. Collaborate for development of the region

Article 2: Scope for Cooperation

The collaboration under this MoU will include, but not be limited to the following:

2.1 Scope of work - SSPU:

SSPU will start short term certificate programs at the infrastructure provided by the Center through its various skilling initiatives. SSPU will offer entire implementation of the program including selection, training, examination to certification. SSPU will provide all the collateral to Center to spread awareness about various training programs. It will jointly conduct awareness and information sessions as necessary.

2.2 Scope of work - Centre:

Centre will provide all the necessary infrastructure including minimum two classrooms equipped with projector and training equipment, office space for trainers, reception area etc. Center will mobilize candidates as per the pre-requisites so that SSPU can conduct selections.

Article 3: Responsibilities of the Parties

3.1 SSPU:

- Identify and nominate one point of contact for all communications
- Provide necessary support to implement skill training programs
- Plan for training batches at locations jointly decided by both parties

3.2 Center:

- Identify and nominate one point of contact for all communications
- Provide necessary support for promotions and mobilization besides providing the infrastructure

3.3 Joint Responsibilities:

- Establish a framework for project and quality monitoring
- Promote skill education in the region
- Evaluate the progress and effectiveness of activities under this MoU periodically
- Collaborate and work on impactful joint projects, grants, schemes etc.

Article 4: Intellectual Property Rights

The intellectual property generated under joint initiatives shall be shared by the Parties.

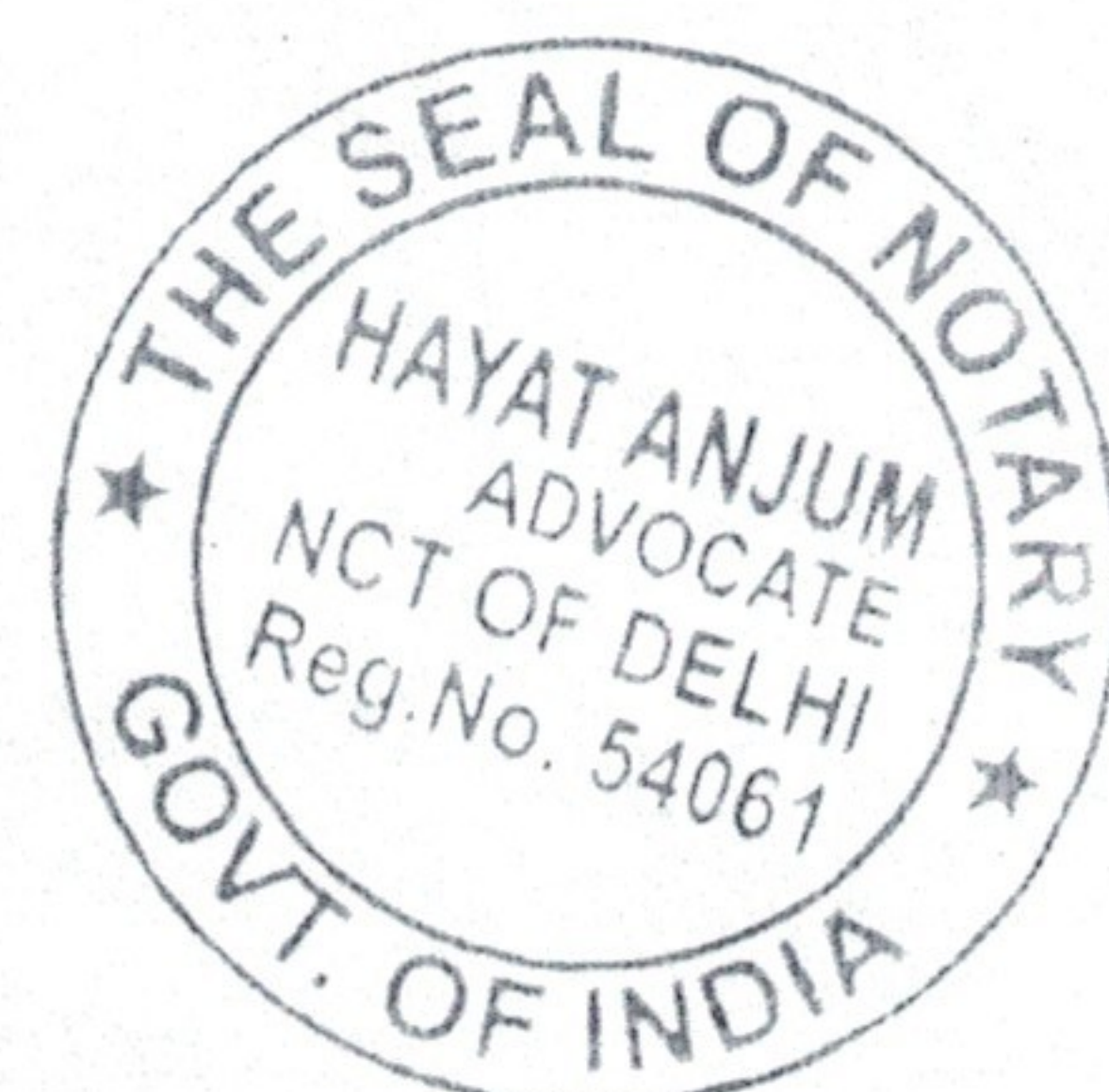
Article 5: Duration and Termination

- This MoU shall remain in effect for a period of **One** year from the date of signing and may be renewed upon mutual agreement.
- Either Party may terminate this MoU by providing a written notice of Six (6) months to the other Party.
- Termination of the MoU shall not affect ongoing programs or projects initiated prior to the notice of termination.

Article 6: Dispute Resolution

Any disputes arising under this MoU shall be resolved amicably through consultation and negotiation between the Parties.

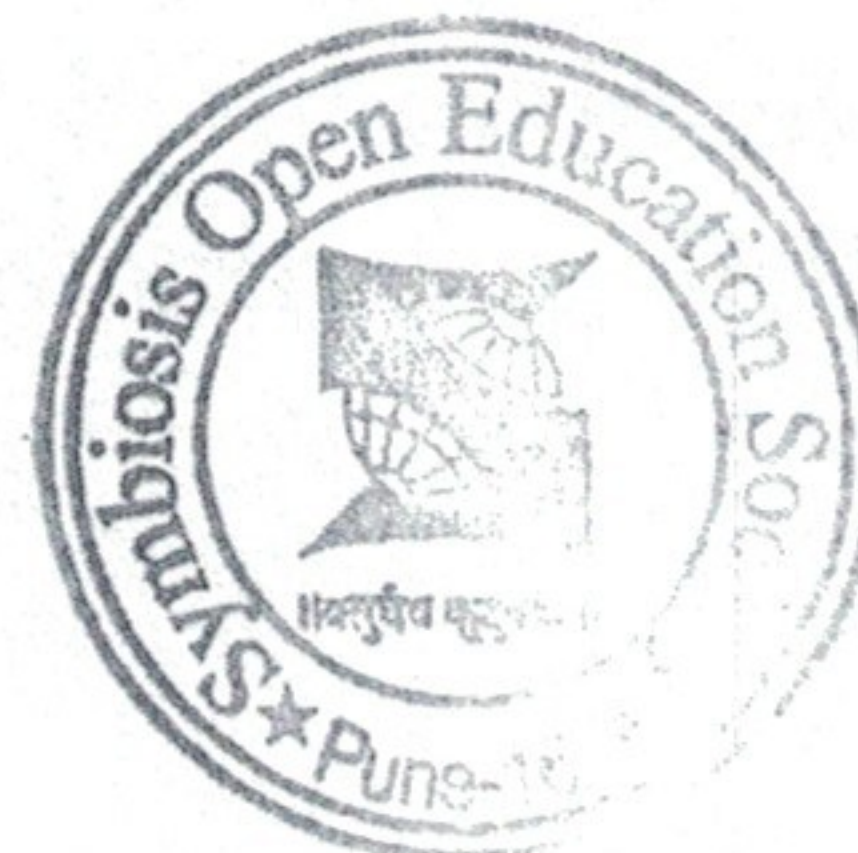

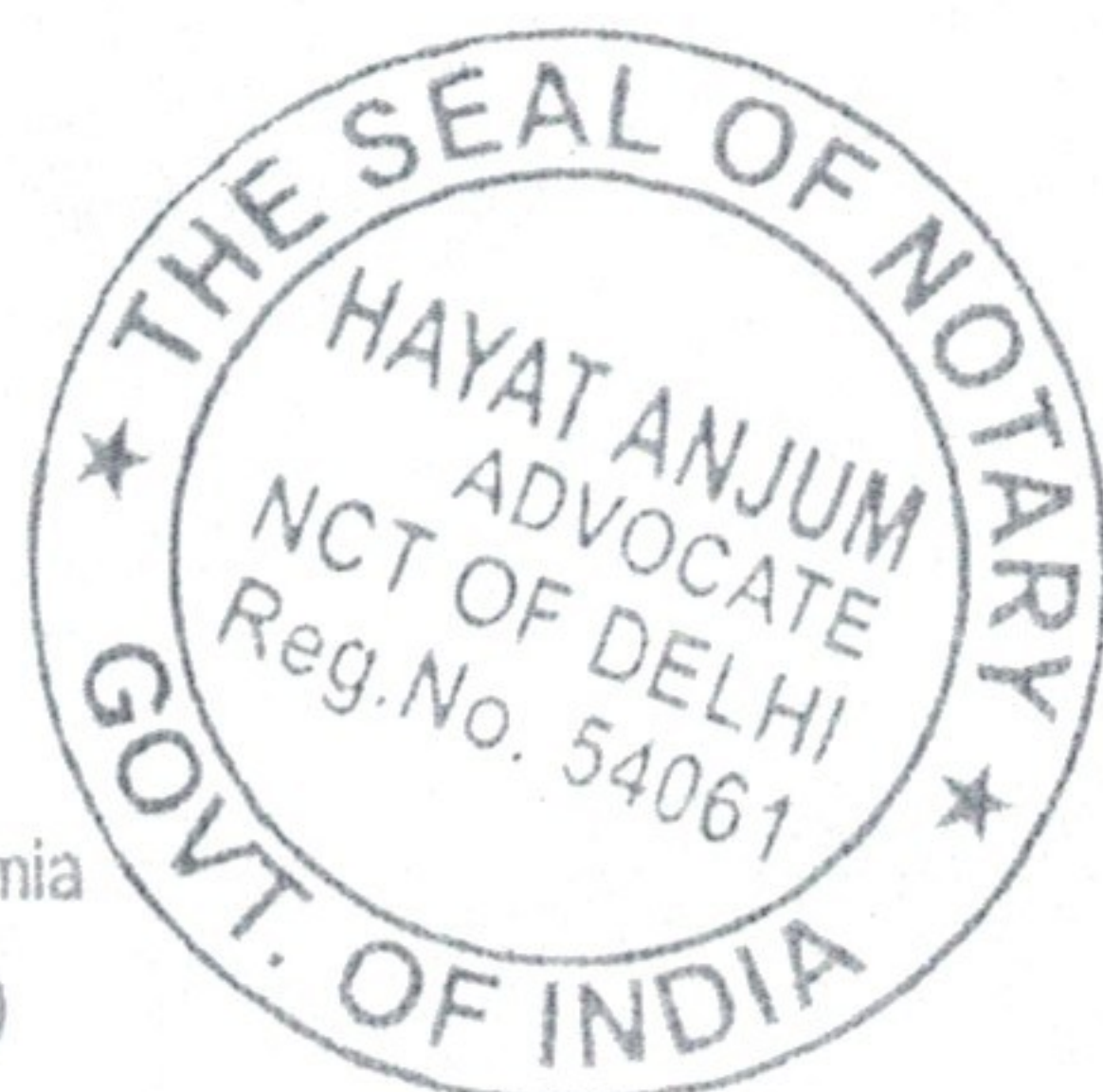

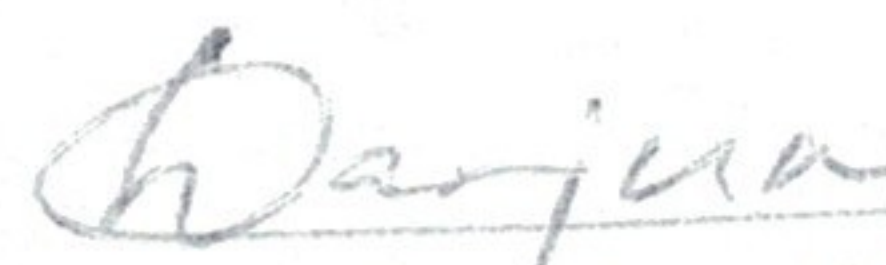
