



MEMORANDUM OF UNDERSTANDING
on

Academic and Research Cooperation
between

ALISHER NAVA'I TASHKENT STATE UNIVERSITY OF THE UZBEK
LANGUAGE AND LITERATURE

and

JAMIA MILLIA ISLAMIA (A CENTRAL UNIVERSITY), NEW DELHI,
INDIA

Alisher Nava'i Tashkent state university of the Uzbek language and literature, Uzbekistan, and Jamia Millia Islamia, A Central University created by an enactment of the Parliament of India, located in New Delhi India in recognition of their common interest in promoting mutual cooperation in the area of education and research, have set forth the following Memorandum of Understanding (MoU):

Article I: Purpose

The purpose of this MoU is to develop academic and research cooperation on the basis of equality and reciprocity and to promote a sustainable partnership and mutual understanding between the two universities.

Article II: Scope of Cooperation

Both universities undertake to promote and develop academic cooperation as follows:

1. Exchange of academic and administrative staff and undergraduate and graduate students.
2. Cooperation in research and the presentation of its results.
3. Supply and exchange of academic materials, publications and other scientific information.
4. Collaboration and exchange of resources and staff in the area of library and other auxiliary services.
5. Other academic and educational projects and programs to which both universities agree to carry out.

Article III: Financial Arrangement

1. Both universities agree that all specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds.
2. Both universities agree to seek financial support from national and international organizations for the cooperative activities to be undertaken as stated under the terms of this MoU.

Article IV: Addendum Describing Activities

A detailed description of the scope of activities shall exist in the form of an addendum to this MoU and constitute an integral part of the Memorandum of Understanding. The addendum may include the following:

1. Elaboration of the responsibilities of each university for the agreed upon activity.
2. Schedules for the specific activity.
3. Budgets and sources of financing for the specific activity.
4. Any other items deemed necessary for the efficient management of the specific activity.

Article V: Intellectual Property Rights and Publication

1. Both universities will share all data and research findings, patent rights, copyrights, and other intellectual property rights to any discoveries, inventions and products resulting from this MoU.
2. Both universities must give written approval for the utilization and publication of the data and research findings.
3. Detailed management of the Intellectual Property Rights and Publication shall be defined in the Agreement for Implementation of each activity.



Article VI: Settlement of Differences

Differing viewpoints and interpretations of this MOU shall be settled amicably by mutual consultation or negotiation.

Article VII: Amendments, Duration and Termination


1. Amendments to this MOU can only be written by mutual consent of the two universities.
2. This MOU shall be in effect from the date of its signing and be valid for the duration of 5 (five) years from that date, and will be automatically renewed on an annual basis thereafter, unless terminated or replaced with a new MOU.
3. This MOU may be terminated by either party by written notice at least 2(Two) months in advance. Such termination or notice thereof shall not affect the completion of existing activities or programs as agreed upon in any Agreement for Implementation.

This MOU is prepared in English and two (2) original copies of this MOU are produced. Both copies are authentic. As witness to their consent to this MOU, the appropriate authorities here to provide their signatures:
