

MEMORANDUM OF UNDERSTANDING

BETWEEN



INDIAN AIR FORCE AND JAMIA MILLIA ISLAMIA FOR HIGHER EDUCATION OF AIR FORCE PERSONNEL

This memorandum of understanding (hereinafter referred to as "MOU") is signed on 13th day of August 2015 at New Delhi.

By & Between

The Indian Air Force represented by the Assistant Chief of Air Staff (Education) Air HQ RK Puram New Delhi 110066, (hereinafter referred to as "IAF"), on one part

AND

Jamia Millia Islamia, a Central University, New Delhi 110025 (hereinafter referred to as "Jamia") represented by its Registrar on the other part.

- 1. Whereas, the Indian Air Force (IAF) is an organisation of the Government of India and part of the Defence forces of India under the Ministry of Defence, which *inter-alia* is also responsible for catering to the educational and training needs of personnel in IAF. The IAF is committed to maintain high standards of training and education amongst all levels of Air Force personnel.
- 2. Whereas, it is the statutory object of the Jamia Millia Islamia to disseminate and advance knowledge by providing instructional, research and extension facilities in such branches of learning as it may deem fit and shall endeavour to provide to students and teachers the necessary atmosphere and facilities for the promotion of:-
 - (a) Innovations in education leading to restructuring of courses, new methods of teaching and learning and integral development of personality;
 - (b) Studies in various disciplines:
 - (c) Inter disciplinary studies;
 - (d) National integration, secularism, and international understanding.

3. <u>Objective.</u> This MoU records mutual intent for academic collaboration between the IAF and Jamia for academic and technical advancement and progression of Air Force personnel (NCO, SNCO and Officers). The IAF conducts ab-initio / In- service training programs for its personnel at its training centres situated at different locations in the country. The objective of this MoU is to work towards evaluation and credit determination of such training programs/ courses vis-à-vis credit value of courses conducted by Jamia with a view to facilitate admission of personnel who have successfully undergone ab-initio/In- service training programs/ courses into the second or third year of courses conducted by Jamia and complete their Graduation / Post Graduation / Doctoral Programme through the medium of distance learning.

4. Equivalence Committee.

- (a) The IAF and Jamia shall jointly constitute an equivalence committee of such number and members as may be mutually agreed upon nominated respectively by the Air Force and Jamia.
- (b) The equivalence committee shall proceed to carry out evaluation and credit determination of the different ab-initio/In-service training /programs conducted by the IAF at its training centres, compare the same to credit value of courses conducted by Jamia and assign appropriate weightage to the ab-initio/In-service training programs. The IAF shall make arrangements and facilitate inspection and evaluation of the ab-initio/In-service training facilities at its different training centres for assessment of quality and content of theoretical and practical components.
- (c) The IAF ab-initio/ In-service training centres will continue functioning as autonomous bodies conducting their training, courses and examinations as hitherto in force. The accumulated credit point from such approved training/courses are intended to be translated to appropriate degree or other courses conducted by Jamia so as to count towards the total number of credits required for grant of equivalent qualifications of Jamia.

- 5. Admission to Jamia Courses/ Programs. In the first instance, the intended collaboration shall be for Air Force personnel who have successfully completed evaluated ab-initio/ In- service training programs/courses at Air Force training centres. Depending upon the credit value as evaluated and determined by the Evaluation Committee of training /courses completed by such personnel, they shall be afforded the facility of being admitted to the second or subsequent years of programs/ courses conducted by Jamia so as to enable such personnel to acquire equivalent qualifications awarded by Jamia through the medium of distance learning.
- 6. Governance of scheme of collaboration. Upon completion of exercise of evaluation and assignment of Credit Values to identified training programs/courses conducted at the different ab-initio/In- Service training centres of the IAF, one or more joint committees shall be constituted for purposes of administration and for ensuring proper functioning of the scheme. The committees so formed will also monitor all academic matters including content and quality of training programs/courses, revision or updation thereof, periodic inspection, conduct of tests and examinations.
- 7. <u>Copyright and Intellectual Property.</u> All copyrights of the course materials (print/audio/video) developed by Jamia shall rest with Jamia, and all copyrights of the training/courses materials developed by the IAF shall rest with the IAF, and copyrights in respect of the courses developed jointly by Jamia and IAF shall be held jointly by them.
- 8. <u>Validity.</u> This MoU will be effective when signed by both the aforesaid parties and shall remain in effect till its termination. This MoU may be amended at any time with mutual written consent of both the parties.
- 9. <u>Termination.</u> This MoU may be terminated at any time by mutual consent or by notice of six months from either party to the other party.
- 10. <u>Interpretation.</u> In case any doubt or difference arises as to interpretation of the provisions of this MoU or as to matters not provided herein, the parties shall consult each other and resolve such doubts or differences in good faith.

- Dispute Resolution. In case of any dispute/point of disagreement on 11. any issue, it would be referred to Dispute Resolution Committee constituted for the purpose consisting of members from both JMI and IAF. In case any dispute remains un resolved, cases related to personnel and discipline would be referred to Air Officer Personnel Air HQ VB New Delhi and cases related to academics will be referred to VC of JMI and their decision shall be final and binding.
- Governing Law. The Memorandum shall be governed, interpreted and 12. construed in accordance with substantive laws of India.
- Any notice, approval consent or notification required or 13. Notices. permitted to be given hereunder shall be in writing in English and shall be personally delivered or transmitted by fax to the addresses specified below or to such other addresses as may, from time to time be given, by each party to the other party in writing.
