The Jamia Millia Islamia and the University of Applied Sciences Erfurt (hereinafter referred to as the "parties") with this Memorandum express their interest to coordinate and collaborate in academic activities pertaining to effective and mutually beneficial cooperation, to develop academic and cultural exchange and to extensively cooperate towards the internationalisation of higher education.

1. The parties strive to encourage direct contact between students and staff of their various faculties and institutes. The Parties have agreed upon the following:
 - I. Exchange of graduate and undergraduate students for study and research
 - II. Exchange of faculty members for research, lectures and discussions
 - III. Exchange of non-academic staff for exchange of experiences
 - IV. Joint research activities
 - V. Co-organisation and participation in lectures, seminars and conferences
 - VI. Exchange of academic materials and academic publications and information
 - VII. Co-operation in administrative issues
 - VIII. All other relevant activities of mutual interest

The themes of joint activities, the conditions for utilising the results achieved and the arrangements for specific visits, exchanges and other forms of co-operation will be negotiated separately for each specific case by the concerned parties and will be agreed upon in writing prior to the initiation of the particular programme or activity.

Nothing therefore shall diminish the full autonomy of either Party, nor will any constraints be imposed by either upon the other in carrying out this Memorandum.
